The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of February.

Incident reports:

Case # 14-1099, 02/07/2014, at 0205 hrs – 1503 S. 81 St, Captain Nick's Tavern

On 02/07/2014 at approximately 0205 hrs., Officers responded to 1503 S. 81 St, Captain Nick's Tavern, for a pedestrian struck by a vehicle. The victim stated she was standing outside the tavern when two females, who were parked in front of the tavern, started yelling at her. The passenger of the vehicle grabbed the victim by the hair and told the driver of the vehicle to go, causing victim to be dragged approximately ten feet before being released. The victim hit her head on the ground when she was released and suffered swelling to the back of her head as a result of this incident. The driver was arrested for Recklessly Endangering Safety and OWI 2nd Offense – causing injury. All parties were inside the tavern prior to the altercation. This case was reviewed by the Milwaukee County District Attorney's Office.

Case # 14-1169, 02/09/2014, 0208 hrs., - 1022 S. 60 St, 1022 Pub and Grub

On 02/09/2014, at 0208 hrs., Officers responded to the 1022 Pub and Grub, 1022 S. 60 St., for two males physically fighting outside of the bar. Justin Roth was highly intoxicated and covered in snow. He was aggressive with Officers and was subsequently arrested for Disorderly Conduct. Roth's girlfriend, "Amber", was the bartender.

Case # 14-1357, 02/15/2014, at 0210 hrs – 9105 W. Lincoln Av., The Draft

On 02/15/2014, at approximately 0210 hrs., Officers responded to The Draft, 9105 W. Lincoln Av, for an assault. Carmen Rodriguez reported an unknown female struck her in the face outside of the bathroom, causing a small abrasion to her forehead. Three females then began kicking

and punching her on the ground for approximately five minutes. Rodriguez and her friend were escorted out of the bar by security. Rodriguez then called the police. The suspects were no longer on scene and never identified.

Case #14-1377, 02/16/2014, 0120 hrs., - 8031 W. Greenfield Av., Paulie's Pub

On 02/16/2014, at 0120 hrs., Officers responded to Paulie's Pub, 8031 W. Greenfield Av regarding a female harassing a band member. Colette Fredrick got into an argument with Robert Gayle. Fredrick smashed a bottle on a table and threw it at Gayle prior to leaving the bar. Fredrick left in her vehicle and was later stopped by Officers. She was taken into custody and cited for Disorderly Conduct. The two parties had dated in the past.

Case #14-1436, 02/18/2014, 0202 hrs., - 7413 W. Greenfield Av, Benno's

On 02/18/2014, at 0202 hrs., Officers responded to the 7413 W. Greenfield Av, Benno's, for a physical altercation inside the bar. Three parties were arrested for Battery and two other parties were arrested for Disorderly Conduct. All parties were booked, cited and released. The owner of the tavern called 911 and was cooperative with the Officers.

Case # 14-1782, 02/28/2014, at 2129 hrs – 1503 S. 81 St, Captain Nick's Tavern

On 02/28/2014, at 2129 hrs., Officers responded to 1503 S. 81 St., Captain Nick's Tavern for a woman who had been punched in the face. Officers spoke with Tom Giesege who said his girlfriend, Penny Alderman, had gotten into an argument with another woman. Officers reviewed the video surveillance, which revealed Penny punch the other female in the face. Penny was arrested and issued a Municipal Citation for Battery.
