I am responding to the Notice of Hearing mailed out regarding the Special Use Permit being sought by *Get Them While They're Hot Tamales*, at 7525 West Becher Street.

There have previously been two catering businesses in that location. When catering trucks are parked in front of the building, close to the corner, it is next to impossible to see past the trucks to look for on-coming westbound traffic. In order to do so, you literally have to go half way into the eastbound lane before you can determine if it is safe to turn left.

We ask the Common Council and the business to consider this safety issue and take the necessary steps to ensure that residents of 83rd Street are not put in a dangerous situation.
