NOTICE IS HEREBY GIVEN that the following initial resolutions have been adopted at the meeting of the Common Council of the City of West Allis held March 18, 2008:

RESOLUTION NO. R-2008-0067

INITIAL RESOLUTION AUTHORIZING \$2,000,000 GENERAL OBLIGATION BONDS OF THE CITY OF WEST ALLIS FOR SANITARY SEWER IMPROVEMENTS

RESOLVED that the City of West Allis, Milwaukee County, Wisconsin, borrow an amount not to exceed \$2,000,000 by issuing its general obligation bonds for the public purpose of financing sanitary sewer improvements.

RESOLUTION NO. R-2008-0068
