Officer Schultz reports...Disorderly Conduct

INITIAL CALL

On 01/02/15 at approximately 1548 hours, officers were dispatched to 6200 W. Greenfield Ave for a male party smashing a window.

CONTACT WITH JOSE J. FERREIRA/OFFICER OBSERVATIONS

I made contact with Jose J. Ferreira, M/W, 01/09/80, who was highly intoxicated. Ferreira was swaying and stumbling on the sidewalk and was very confused. Ferreira had a very strong odor of intoxicants emitting from his person and could not give his current address as well as other information to officers. Ferreira's speech was slurred and his eyes were very droopy.

Ferreira became very argumentative and denied breaking the window, however, there were pieces of glass on his coat and in his hair.

CONTACT WITH (OWNER) (SUPP FROM CPL NELSON)**LACK OF CONSENT**

The owner of Six Points Pub and Grille did not give anyone consent to break his front picture window.

PROPERTY (SUPP FROM CPL NELSON)**ARREST DECISION**

Based on witness statements and an argumentative and intoxicated demeanor, Ferreira was arrested for Disorderly Conduct. Ferreira was handcuffed (double locked for safety) and placed in the back of a WAPD Squad car to be transported to WAPD for booking.

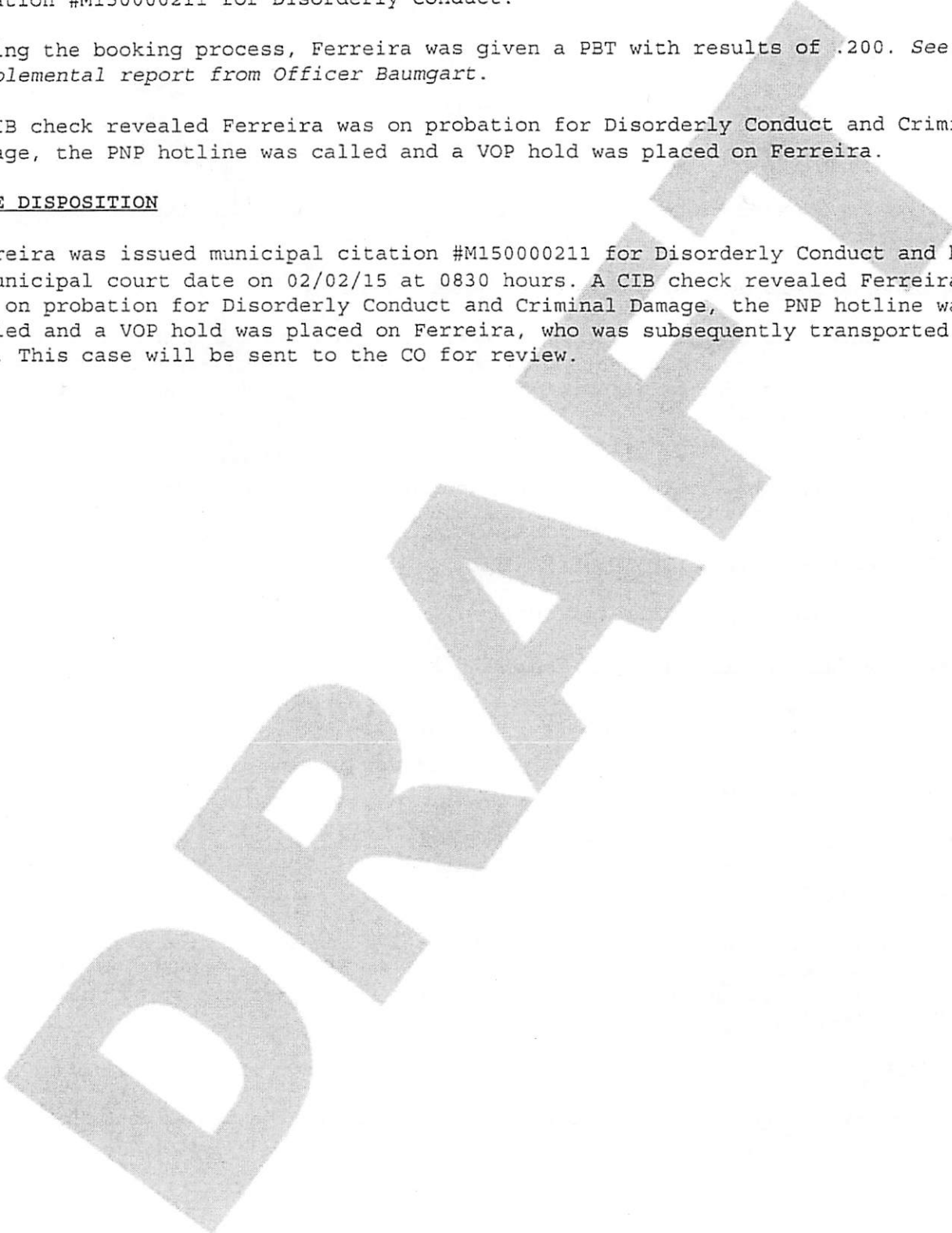

A CIB check revealed Ferreira was on probation for Disorderly Conduct and Criminal Damage, the PNP hotline was called and a VOP hold was placed on Ferreira.

CASE DISPOSITION

Ferreira was issued municipal citation #M150000211 for Disorderly Conduct and has a municipal court date on 02/02/15 at 0830 hours. A CIB check revealed Ferreira was on probation for Disorderly Conduct and Criminal Damage, the PNP hotline was called and a VOP hold was placed on Ferreira, who was subsequently transported to CJF. This case will be sent to the CO for review.
