NARRATIVE

Officer Schultz reports...Disorderly Conduct

INITIAL CALL

On 01/02/15 at approximately 1548 hours, officers were dispatched to 6200 W. Greenfield Ave for a male party smashing a window.

CONTACT WITH JOSE J. FERREIRA/OFFICER OBSERVATIONS

I made contact with Jose J. Ferreira, M/W, 01/09/80, who was highly intoxicated. Ferreira was swaying and stumbling on the sidewalk and was very confused. Ferreira had a very strong odor of intoxicants emitting from his person and could not give his current address as well as other information to officers. Ferreira's speech was slurred and his eyes were very droopy.

Ferreira became very argumentative and denied breaking the window, however, there were pieces of glass on his coat and in his hair.

ARREST DECISION

Based on witness statements and an argumentative and intoxicated demeanor, Ferreira was arrested for Disorderly Conduct. Ferreira was handcuffed (double locked for safety) and placed in the back of a WAPD Squad car to be transported to WAPD for booking.
