THE WEST ALLIS COMMON COUNCIL TO JAMES ADAMS AND JOHN WERNER:

You are hereby notified that a sworn complaint, a copy of which is attached, has been duly made and filed, requesting a hearing on the suspension, revocation, or non-renewal of your Class B Beer, Class B Liquor, Instrumental Music, and Dance Hall licenses pursuant to the provisions of sec. 125.12, Wis. Stats., and West Allis Revised Municipal Ordinance 9.02, 9.032, and 9.05.

NOW THEREFORE, you, James Adams and John Werner, are hereby summoned to appear before the License and Health Committee of the West Allis Common Council in Room 128 of the West Allis City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, on October 23, 2012, at 5:30 p.m., or as soon thereafter as this matter can be heard, to admit or deny the allegations in the complaint. You may be represented by counsel on this date.

In the case of your failure to appear as required by this summons, the allegations in the complaint against you shall be taken as true and, if the License and Health Committee of the West Allis Common Council finds the allegations sufficient, a recommendation that your license(s) be suspended or revoked will be made to the full Common Council. The Common Council may then vote to suspend, revoke, or not renew your license(s).

You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this proceeding at your expense.

5. That Noble Restaurants, LLC is the holder of a Dance Hall License, License Number 12-1851, to allow dancing under West Allis Revised Municipal Code Section 9.05, issued by the West Allis Common Council on June 29, 2012.
6. That Noble Restaurants, LLC does business under the trade name "Tanner Paull."
7. That James Adams is Noble Restaurants, LLC's registered agent for the purpose of legal service, pursuant to Wis. Stat. § 183.0105(8)(a).
8. That John Werner is the agent of Noble Restaurants, LLC's above-referenced licenses, pursuant to Wis. Stat. § 125.06.
9. That in June and July 2012, the West Allis Police Department became aware that Tanner Paull had been holding several underage parties hosted by "DJ Boobah."
10. That due to the parties, an increased police presence was required in the area.
11. That investigation revealed that alcohol may have been served at the parties and persons under the age of 21 attended said parties. (See attached Exhibit 1.)
12. That, in part, due to the problems occurring with underage parties, the West Allis Common Council adopted West Allis Revised Municipal Code Section 9.02(22), which requires licensees to notify the West Allis Police Department if they are having underage persons on the premises without their parents, among other restrictions.
13. That on July 11, 2012, Lieutenant Chad Evenson went to Tanner Paull to speak with Werner or Adams about the new ordinance, but the business was empty. Upon returning to the police station, Lieutenant Evenson called Adams, who told him that he should contact Werner because Werner was the license holder.
14. That, subsequently, Lieutenant Evenson called Werner and left him a voicemail message to return his call. On July 12, 2012, he called Werner again, made contact with him, and advised him of the new ordinance. However, before Lieutenant


Evenson could discuss the specifics of the new ordinance, Werner interrupted him and stated that he was selling the business in the near future. When Lieutenant Evenson told him that since he (Werner) was still in control of the business, he wanted to explain the new ordinance to him in person, Werner told him that he would call him back in five minutes. Werner never did contact Lieutenant Evenson, so Lieutenant Evenson mailed a copy of the new ordinance to the business on July 13, 2012.

15. That Assistant City Clerk Monica Schultz notified Werner in writing on July 17, 2012 that he was required to appear at the July 24, 2012 License and Health meeting to discuss the Class B Tavern License and new ordinance. (See attached Exhibit 2.)
16. That Werner called and spoke to Ann Marie Neff, a clerk employed with the City, and informed her that he could not attend the meeting because he would be out of town.
17. That accordingly, Assistant City Clerk Monica Schultz notified Werner in writing on July 27, 2012 that he was required to appear at the August 7, 2012 License and Health meeting to discuss the Class B Tavern License and new ordinance. (See attached Exhibit 3.)
18. That Werner did not appear and did not contact the clerk's office.
19. That Assistant City Clerk Monica Schultz notified Werner in writing on August 16, 2012 that he was required to appear at the August 28, 2012 License and Health meeting to discuss the Class B Tavern License and new ordinance. (See attached Exhibit 4.)
20. That Werner did not appear and did not contact the clerk's office.
21. That the conduct of Noble Restaurants, LLC, by agent John Werner, substantially relates to the licensed activity contrary to West Allis Revised Municipal Code


Section 9.02(12)(b) and 9.02 (12)(d) and is grounds for non-renewal, suspension, or revocation of its Class B beer and liquor license, instrumental music license, and dance hall license.

WHEREFORE, Michael J. Czaplewski, requests that Noble Restaurants, LLC, by agent John Werner, be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Class B beer and liquor license, instrumental music license, and dance hall license of Noble Restaurants, LLC should be revoked, suspended, or not renewed.





HEARING PROCEDURE GUIDE

LICENSE AND HEALTH COMMITTEE WEST ALLIS COMMON COUNCIL CITY OF WEST ALLIS

I. *Convene the Hearing.*

- A. This is a license hearing pursuant to sec. 125.12 of the Wisconsin Statutes, in the matter of the Complaint against Noble Restaurants, LLC, d/b/a Tanner Paull.
- B. Let it be noted for the record that the following Committee members are present:
(Identify by title and name.) Would you state your appearances. *(Licensee and attorney should identify themselves. City Attorney and Prosecutor to identify themselves.)*

II. *Nature of the Hearing. (Sec. 125.12, Stats., attached.)*

- A. I am Michael Czaplewski, Chairman of the License and Health Committee of the Common Council of the City of West Allis.
- Mr. Werner, a Complaint against you has been filed with this Committee. Under the provisions of sec. 125.12 of the Wisconsin Statutes, this hearing has been convened for the purpose of determining whether any of the charges against you are true, and to make a recommendation based upon that determination. This Committee will examine all the evidence concerning the charges through inquiry to both sides. The Committee will evaluate and then impartially weigh the evidence. It will determine whether or not any of the charges have been proven solely upon the evidence introduced at this hearing.
- B. This hearing is open to the public.

- C. A verbatim record of the proceedings is being made by audio recording.
- D. You may be represented by an attorney. Assistant City Attorney Jenna Merten is here as the Prosecutor and will present the case against you to the Committee. The City Attorney is present and will serve as legal advisor to the Council. The City Attorney will advise the Committee on questions of law and procedure and may also direct questions to witnesses on behalf of the Committee.
- E. You may present evidence, call and examine witnesses, and cross-examine witnesses against you. Such witnesses will be sworn.
- F. Subject to a motion for consideration by the full Committee, made by a member of the Committee, I will rule upon all questions, objections and motions as to procedural matters, admissibility of evidence, and similar issues. All objections, questions and motions, should be directed to me.
- G. You may testify on your behalf with regard to the charges against you. However, what you say will be considered as evidence. Further, if you do testify, you may be cross-examined.
- H. If a charge or charges against you are proven, you are advised that the Committee may recommend to the Common Council that your licenses be suspended, revoked, or not renewed and that the Common Council may accept or reject such recommendation and may determine, upon such recommendation, whether your licenses should be suspended, revoked or not renewed.

III. *The Complaint. (Summons and Complaint attached.)*

- A. You have been served with a Summons for this hearing and a copy of the Complaint against you, which have been filed with the Committee for a determination. I now

request the Clerk to append as exhibits to the record, a copy of the Summons and Complaint, together with a copy of the Affidavit of Service.

- B. Do you admit to any of the allegations in the complaint or are there portions which are not contested?

IV. *Evidence.*

- A. I will now ask Ms. Merten to present evidence as to the charges before the Committee.

All witnesses who testify before the Committee should be sworn. The form of oath which should be administered to each witness by the Chairman or court reporter is as follows:

"Do you solemnly swear that the testimony you shall give in this matter shall be the truth, the whole truth, and nothing but the truth, so help you God?"

If the witness states that he has conscientious scruples against taking the oath, or swearing in the usual form, administer the following:

"Do you solemnly, sincerely and truly declare and affirm that the testimony you shall give in this matter shall be the truth, the whole truth and nothing but the truth; and that you do this under the pains and penalties of perjury?"

(After each witness testifies on direct examination, permit the opposing party to cross examine the witness, then, if desired, allow redirect and recross examination until both sides have no further questions of each witness. The Chairman may limit the questioning in his discretion if the questions are repetitive or irrelevant.)

- B. Does any member of the Committee wish to ask questions of the witness?
C. Does the City Attorney wish to ask questions of the witness?

(Questions of Committee members or City Attorney may prompt either side to ask additional questions. This should be permitted, following the same procedure above.)

D. Does the Prosecutor wish to present any further evidence? *(If not, proceed.)*

E. I will now ask the licensee to present its evidence.

(Follow same procedure as with the complainant's evidence, i.e., swear witness, direct examination, cross-examination, etc.)

F. Does any member of the Committee wish to ask questions of the witness?

G. Does the City Attorney have any questions of the witness?

(Permit further questions by the parties, if requested.)

H. Is there anything further?

(If nothing further, proceed.)

I. Does the Prosecutor wish to make a closing statement?

J. Does the licensee wish to make a closing statement?

K. Rebuttal by Prosecutor.

V. *Adjourn for Deliberation.*

Having heard all evidence in this case, the Committee will go into closed session, pursuant to sec. 19.85(1)(a), Stats., to deliberate. Upon completion of the deliberation, the Committee will reconvene in open session and at that time announce its findings and determinations.

VI. *Announce Deliberation.*

Read the basics of the decision the Committee arrived at.

Findings and recommendations to be drafted by the City Attorney.




