#### A. CALL TO ORDER

Mayor Devine called the meeting to order at 3:31 p.m.

#### C. APPROVAL OF MINUTES

1. [25-0438](#) September 12th, 2025 AARB Minutes.

Ald. Weigel moved to approve, Clark seconded, motion carried.

#### D. MATTERS FOR DISCUSSION/ACTION

2. [25-0439](#) Appeal by Joel Galarza of the Dangerous Dog Order issued on September 24th, 2025 for Falcor at 1475 S. 84th St. (AARB-31)

Clark motioned to modify the dangerous dog order to include installing a spring loaded gate and latch on the fence at the property within 30 days, signage within 10 days, insurance of \$100,000, and the dog must be muzzled while in public, Ald. Weigel seconded, motion carried unanimously.

3. [25-0440](#) Appeal by Avree L. Gundersen of the Dangerous Dog Order issued on September 28th, 2025 for Bailey at 1482 S. 84th St. (AARB-32)

Clark motioned to modify the dangerous dog order to include signage on apartment door, muzzled outside of apartment unit, insurance of \$100,000, and the dog is prohibited from West Allis parks, Ald. Weigel seconded, motion carried with Mayor Devine abstaining.

4. [25-0441](#) Appeal by Timothy Young of the residency decision issued on August 18th, 2025 regarding 2027 S. 79th St. (AARB-30)

Clark motioned to deny the residency appeal, Ald. Weigel seconded, motion carried unanimously.
