The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of February, 2022;

**INCIDENT REPORTS:**

**CASE #22-004740- 02/11/22 - 0940hrs. - Captain Nick's - 1503 S. 81 St.**

**Detective Madden Reports:**

On 02/11/22 at 0940 hrs., officers responded to a report of an active fight at Captain Nick's bar. When police arrived on scene, the involved parties were no longer fighting. Daniel Kennedy and Jonathan Bush stated Anthony Rath was being aggressive and punched Bush in the face. Rath began fighting with Kennedy and Bush. Rath's girlfriend, Sara Donahue, also tackled Kennedy. Rath will be issued a municipal citation for Disorderly Conduct.

Raush, [REDACTED] arrived on scene to assist with the incident. All staff was cooperative and they also assisted us with video surveillance for the separate incident.
