#### **Short Narrative**

Nelson: on 03/31/07 at about 0221 hrs. T/C at Lenny's Tavern, 6309 W. National Ave. Officers responded to Lenny's on a report of a fight outside of the business with a possible shot fired. Contact made with Daniel J. Kachelmeier, m/w, 07/22/78 and Christopher M. Collen, m/w, 04/13/86. Kachelmeier assisted Collen as Collen was struck by an unknown female with her shoe. Collen (20yoa) stated he was inside of Lenny's prior to our arrival, was NOT carded, but did not consume any alcoholic beverages. There were no shots fired and no fighting was observed at the scene. Collen was treated for a cut on his hand by WA rescue. Collen refused transport to the hospital for his injured hand.
