**RESOLUTION TO AUTHORIZE THE AGREEMENT BETWEEN THE CITY AND
NEWPORT NETWORK SOLUTIONS INC. TO PURCHASE NEW SURVEILLANCE
CAMERA SERVER INFRASTRUCTURE FOR \$40,500 FROM ACCOUNT 354-6051-
517.31-01**

WHEREAS, The City has 350+ security cameras installed throughout the City that have their recordings captured on a set of servers that are over 9 years old and have reached end-of-life; and

WHEREAS, It has become a challenge for us to meet the recommendations from the State of Wisconsin to retain the footage for all of these cameras for 120 days; and

WHEREAS, This project was part of the Capital Improvement Process and was vetted and approved as part of the five-year planning program; and

WHEREAS, Due Diligence was performed to find the least costly alternative to modernize our server infrastructure while also increasing our capacity. Rather than buying from our usual camera software supplier (ExacQvision), we went directly to a manufacturer supplier (Newport). In doing so, we are able to keep the cost the same as what was requested in the CIP request but will obtain about 2.5 times the storage that is available on these devices; and

WHEREAS, By having more storage available, we open up the opportunity to increase the resolution and frame speed (number of images captured per second) on some of our more heavily accessed camera views; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the quote dated June 22nd, 2022 for providing two new camera storage servers, software and support for 5 years at a total cost of \$40,500 be and is hereby accepted. The account where this will be charged is account # 354-6051-517.31-01.

BE IT FURTHER RESOLVED, that the Information Technology Department be and is hereby authorized to enter into a contract for the aforesaid services.
