P.O. Mees reports...On 03/31/07 at 0201hrs I responded to Magoo's Tavern, 8911 W. National Ave, for a trouble call. Upon arrival I made contact with James R. Ondishko M/W DOB: 10/27/82 and Kyle A. Hansen M/W DOB: 12/23/78 whom stated a M/H/508/150/mohawk/red shirt started a fight in the tavern with another patron. They briefly fought inside and then were forced outside by Ondishko and Hansen. While outside the unknown patron attempted to walk away, but the M/H tried to continue the fight. Ondishko and Hansen once again broke it up. The M/H then tried to fight with Ondishko and Hansen.
