**RESOLUTION TO AUTHORIZE THE PURCHASE OF ONE GENIE GS2632
ELECTRIC SCISSOR LIFT FROM JOHN FABICK TRACTOR COMPANY, INC. FOR
A TOTAL SUM OF \$21,370.40**

WHEREAS, the 2025 approved budget includes \$50,000 for the purchase of the new electric scissor lift; and,

WHEREAS, JFTCO Inc., has provided pricing for the new Genie GS2632 electric scissors lift through the Sourcewell National Cooperative Contract #020923-TER dated May 28, 2025, for the Department of Public Works of the City of West Allis; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this contract meets all desired specifications, and that the proposal received is reasonable; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposal of JFTCO Inc. be accepted.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Common Council of the City of West Allis that the proposal dated May 28, 2025 by JFTCO Inc. for furnishing and delivering one Genie GS2632 electric scissor lift for a sum of \$21,370.40 be and is hereby accepted. Funding for this purchase has been budgeted and is available in the 2025 Capital Improvement Program budget in the amount of \$21,370.40. The purchase will be charged to Account Number 352-4101-533.70-03.

BE IT FURTHER RESOLVED that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid equipment.
