**RESOLUTION TO APPROVE AMENDING CERTAIN ACTIVITIES OF THE FY2019
ANNUAL PLAN OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
PROGRAM RELATIVE TO THE REALLOCATION OF CDBG-CV (COVID)
FUNDING IN THE AMOUNT OF \$131,285**

WHEREAS, the Common Council has approved the FY2019 Community Development Block Grant Annual Action Plans under Resolution R-2019-0402; and,

WHEREAS, the previously approved allocation budget within the FY 2019 Community Development Block Grant (CDBG) Annual Action Plan (B-19- MC [1] 55-0011) will be amended to reallocate funds from a Mortgage Assistance Program to COVID Rent Assistance Programs and to reallocate funds for the a Meal Program to a COVID - Health Department Awareness Program (existing programs) in response to the COVID-19 pandemic. Total reallocations to the aforesaid programs will amount to \$131,285; and,

WHEREAS, the purpose of this public hearing is to provide interested citizens an opportunity to express their views on the reallocation and use of CDBG-CV funds and to provide citizens with information on how these funds are to be utilized; and,

WHEREAS, the utilization of CDBG funds for the previously stated activities meet HUD requirements for the CDBG program; and,

WHEREAS, the proposed amendments were presented to the Community Development Block Grant Committee and the Planning & Zoning Manager recommended approval.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby amends:

FY 2019 Community Development Block Grant (CDBG) Annual Action Plan (B-19- MC [1] 55-0011), to reallocate \$131,285 of FY2019 unallocated CDBG-CV funds to the following activities:

- 1) COVID Rent Assistance Programs; and,
- 2) COVID Health Department Awareness Program.


