The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month the June 2011 licensing period.

**Incident reports:**

**Call # 11-023929, 06/11/2011 at 0328 hrs. Hero's Tavern, 9105 W. Lincoln Ave.**

On 06/11/2011, at approx. 0328 hrs, Officer Noche responded to the 2300 blk of S. 92<sup>nd</sup> St regarding an intoxicated male subject laying near the roadway. The male subject was extremely intoxicated. He was identified and told Officer Noche that he had been drinking at Hero's Tavern. This party was subsequently given a ride home.

**Case # 11-005197, 06/13/2011 at 0045 hrs. The Spot Tavern, 6426 W. Greenfield Ave.**

On 06/13/2011, at approximately 0045 hrs, officers responded to The Spot Tavern for a report of a Robbery. The investigation revealed that a M/B patron was harassing a female dancer during her routine; while the victim dancer was outside the tavern on a cigarette break she observed this person urinating on the exterior of the building. She confronted this person and told him to stop urinating on the building.

The M/B offender allegedly punched the female dancer in the face several times knocking her to the ground and causing injury to her. The offender subsequently took the victim's purse and fled the scene. The identity of the suspect has been established and this investigation is ongoing.

**Case # 11-005332, 06/17/2011 at approx. 0153 hrs. Fiddler's Green Tavern – 6108 W. Burnham St.**

On 06/17/11, at approximately 0153 hrs, officers responded to a fight complaint outside the Fiddler's Green Tavern. Upon officers arrival they observed three parties in front of the aforementioned address. As officers approached one party fled on foot and was subsequently apprehended. A second party who remained on scene had a cut to his eye and was bleeding. The third party apparently ran into his apartment and refused to answer his door for officers. A rescue was summoned for the injured party; however, he refused treatment.

Officers' investigation revealed that this was an altercation between two intoxicated parties who were drinking inside Fiddler's Green tavern. One party was trying to escort the other party from the bar when the person he was trying to escort from the bar punched him in the face (cutting his eye region). It's not clear if this person who was escorting the individual from the bar was a bartender or acting on behalf of the bartender. Two parties were issued citations for Disorderly Conduct.

**Call # 11-025171, 06/18/2011, at approx. 2325 hrs. Hero's Tavern – 9125 W. Lincoln Ave.**

On 06/18/11, at approx. 2325 hrs, Officers were dispatched to clear the lot at 9125 W. Lincoln Ave. patrons from Hero's tavern were using the lot to park their vehicles. Six (6) parking citations were issued to violators.

**Call # 11-025192, 06/19/2011, at approx. 0139 hrs. Flappers Tavern, 7525 W. Becher St.**

On 06/19/2011, at approx. 0139 hrs, Officers were dispatched to Flappers Tavern -- 7525 W. Becher St regarding a noise complaint. The complainant reported loud bar patrons were outside making noise. In addition, the door to the bar was open contributing to the noise. Bar patron were advised to keep the noise level down and to also keep the door to the bar closed.

**Call # 11-025353, 06/20/2011, at approx. 0132 hrs. Flappers Tavern, 7525 W. Becher St.**

On 06/20/2011, at approx. 0132 hrs, Officers were dispatched to Flappers Tavern – 7525 W. Becher St regarding a noise complaint. The complainant reported bar patrons are smoking outside the bar and being loud. Officers responded to the bar, but did not observe anyone outside the bar, or anyone being loud in the bar. Everyone inside the bar, including the bartender was advised to keep the noise down.

**Call # 11-026020, 06/24/2011, at approx. 0123 hrs. HD Hideout Tavern – 6201 W. Mitchell St.**

On 06/24/11, at approx. 0123 hrs, Officers responded to the Hideout Tavern located at 6201 W. Mitchell St regarding a loud noise complaint. Upon officers arrival they could hear loud music coming from the bar. Officers spoke with the bartender who was advised to turn down the music and close the door.

**Call # 11-026014 (positive action by bar personnel), 06/24/2011, at approx. 0015 hrs. Captain Nicks Tavern, 1503 S 81<sup>st</sup> St.**

On 06/24/11, at approx. 0015 hrs, Officers were dispatched to Capt. Nicks Tavern, 1503 S. 81<sup>st</sup> St. regarding a drug complaint, which was called in by bar personnel. The report was that a patron inside Captain Nicks was offering to sell Oxycontin to several customers. The person attempting to sell the Oxycontin was advised to leave the establishment by bar personnel. Officers observed this person causing a loud disturbance while walking down the street. No drugs were found on this person, but he was cited for Disorderly Conduct and held until sober.

**Call # 11-026024, 06/24/2011, at approx. 0224 hrs. Sportz Medicine Bar, 7731 W. Becher.**

On 06/24/2011, at approx. 0224 hrs, Officers responded to a citizen complaint regarding a disturbance outside the Sportz Medicine Bar. Upon officers arrival the complainant advised officers that he is sick of the people that hang out at the bar because of the chronic problems. Tonight at bar close he witnessed a fight between a black and white male. Caller claims no one at the bar calls the police when incidents occur. He is requesting the police pay more attention to the bar.

**Call # 11-026182, 06/25/2011, at approx. 0233 hrs. Shamrox Bar, 6851 W. Beloit Rd.**

On 06/25/11, at 0233 hrs, Officers were dispatched to Shamrox Bar, 6851 W. Beloit Rd. regarding a fight inside the bar. Officers met with the bartender who called police; she indicated that two male subjects got into a pushing match at bar close, but left before officers arrived. One of the parties involved in the fight returned to the bar and spoke with officers. He stated it was a minor incident and no further action was taken.

**Call # 11-026162, (positive action by bar employee) 06/25/2011, at approx. 0037 hrs. Smokin Joe's Tavern, 6139 W. Beloit Rd.**

On 06/25/11, at approx. 0037 hrs, our department received a call from an employee of Smokin Joe's Tavern. He stated an intoxicated woman came into the tavern and tried to order a drink, but was not served due to her intoxication. As she left the bar she entered her vehicle and tried to drive away. Police subsequently arrested this person for OWI.

Call # 11-026804, 06/28/2011, at approx. 2347 hrs. Danny's Lounge, 1900 S. 60<sup>th</sup> St.

On 06/28/11, at approx. 2347 hrs, our department received an anonymous call reporting there was loud music coming from Danny's Lounge. Officer responded and had them close the door.

**Tobacco and Alcohol Compliance checks:**

No alcohol compliance checks were performed in the month of May / June.

Fourteen (14) tobacco compliance checks were conducted on June 27<sup>th</sup>, 2011. One business was in violation of selling cigarettes to a minor – Walgreens, 8333 W. Greenfield Ave.

**Violation of Wisconsin Clean Air Act Smoking Ban;**

There were no reported violations for the month of May / June.
