RE: Motion #743-31, Beer and Wine Provided by a Non-Profit During Fundraising Events

## Dear Sir or Madam:

In response to Motion #743-31, please note that the Common Council of the City of West Allis opposes non-profit organizations providing beer or wine free of charge during a fundraiser event without requiring the organization to hold a municipal license.

Municipal control of the licensing process allows local officials to be informed of when and where events with alcohol are planned. We have concerns with regard to police and fire services and public safety. We have concerns relative to control factors such as prohibiting unaccompanied underage persons on the premises, licensing and training requirements for an operator, and closing times for these types of events. We have concerns about the possible proliferation of unlicensed activity involving alcohol if non-profit organizations do not require licensing.

The City of West Allis exercises due diligence during the alcohol licensing process. There are numerous rules and regulations that must be followed. Deregulation of the licensing for non-profit organizations sends the wrong message. Local governance of the laws related to alcohol sales and alcohol consumption is taken very seriously in the City of West Allis.

We hope and trust you will reconsider your initial action regarding this amendment when it comes time to voting on the budget.
