The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of May.

**Incident reports:**

**Case # 14-3616, 04/30/2014, at 2222 hrs – 6000 W. Burnham St – Taqueria Buenavista**

On 04/30/2014, at 2222 hrs., Officers responded to 6000 W. Burnham St, Taqueria Buenavista for a male party who pointed a handgun at a female party and threatened her with it. Officers entered with firearms drawn. Both individuals were detained. The firearm was located and it was an Airsoft handgun. The party was arrested and issued a municipal citation for Disorderly Conduct.

**Case # 14-3692, 05/03/2014, at 0053 hrs – 1901 S. 60 St. – Las Palmas**

On 05/03/2014, at 0053 hrs., an Officer was approached by a woman in the area of 60 St/W. Burnham St. She stated she had a warrant and wanted to be arrested. Franklin PD confirmed the warrant. She was highly intoxicated. She advised the Officer she had gotten in an argument with her boyfriend in Milwaukee and made her way to West Allis where she was "beaten up" by Security at Las Palmas restaurant; stating the security guard threw her to the ground when she tried to enter. He also punched her at least 12 times in the head. The party did have a cut to the back of her head. Follow up was made with Las Palmas security who stated he only saw the party when she ran across the street in front of the squad car and was placed under arrest. He stated she never attempted to come in the restaurant and appeared highly intoxicated.

**Case # 14-3726, 05/04/2014, at 0047 hrs – 8900 W. Greenfield Av – Larry Michaels Club & Café**

On 05/04/2014, at approximately 0047 hrs., Officers responded to Larry Michaels, 8900 W. Greenfield Av, for a report of a male that broke a gambling machine inside of the business. Officer made contact with the bartender who observed a male throw a glass at a gambling machine and break the machine. The man fled from the business. Two patrons from inside of the bar had tackled the male into the grass. The employee separated the parties and sent them on their way. An arrest was not made.

**Call # 14-18476, 05/07/2014, at 2134 hrs. - 6426 W. Greenfield Av – Spotlight**

On 05/07/2014 at approximately 2134 hrs., Officers responded to 6426 W. Greenfield Av, Spotlight, for two parties physically fighting inside the bar. An Officer spoke to a party at the bar who advised an argument ensued between two people and one person had to be restrained by his friend. The parties left on foot and were gone prior to the Officer's arrival.

**Case # 14-3943, 05/10/2014, at 0100 hrs – 1641 S 68 St – Dog House**

On 05/10/2014, at 0100 hrs., Officers were flagged down at 1641 S 68 St., Dog House, for an anonymous report of underage drinking at the Dog House. Investigation revealed two 20 year old parties had consumed alcohol at the Dog House. They were arrested for Underage Drinking, booked, cited and released. The bartender was mailed a citation for serving underage persons.

**Case # 14-3986, 05/11/2014, at 0201 hrs – 8031 W. Greenfield Av – Paulie's Pub**

On 05/11/2014, at approximately 0201 hrs, Officers observed a fight in the parking lot of Paulie's Pub, 8031 W. Greenfield Av. A party was lying on the ground, unconscious. Two other parties fled the scene. An Officer stopped one of the parties, who was not compliant and the party was tasered. The other party was located and transported back to the station. The victim had a three inch laceration to the back of his head that required 7 stitches. The two Offenders were arrested for Substantial Battery and Resisting/Obstructing an Officer and conveyed to CJF. All parties were inside the tavern, prior to the altercation.
