RESOLUTION R-2026-3751**

**RESOLUTION APPROVING A SUBSTANTIAL AMENDMENT TO THE FY2020-
FY2025 COMMUNITY DEVELOPMENT BLOCK GRANT ACTION PLANS TO
REALLOCATE UNPROGRAMMED BLOCK GRANT FUNDING OF \$85,624 TO
COMPLETE THE LIBERTY HEIGHTS PARK PAVILION PROJECT ACTIVITY**

WHEREAS, construction of a new pavilion for Liberty Heights Park was approved on July 30, 2024 (Resolution R-2024-0447); and,

WHEREAS, the project included the demolition and new construction of a park pavilion, including mobilization/demobilization; site security; building demolition and backfilling; excavation; new pavilion construction, including plumbing, HVAC, and electrical; sewer and water connections; concrete pavement; landscaping; and lawn restoration in accordance with the approved scope of work (PLAN FILE NO. B-839) for the sum of \$1,279,630; and,

WHEREAS, said improvements were made with funding from the Community Development Block Grant (CDBG) funds (Project C23409) in accordance with the national objective of the CDBG Program, assisting the needs of low-income to moderate-income people; and,

WHEREAS, over the past year, work on the pavilion has been substantially completed, and to fulfill the contractual final payment obligation, the project will require an additional \$85,624; and,

WHEREAS, the additional funding necessary for final payment and to complete the program activity may be reallocated from unprogrammed CDBG Federal block grant funding from prior program years; and,

WHEREAS, Common Council approval is required on the reallocation of funds from prior year's project activity to another; and,

WHEREAS, the Liberty Heights Park Pavilion project is anticipated to be completed in spring 2026.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that \$85,624 in remaining/unused budget authority from program years 2020-2025 is reallocated from Unprogrammed Funding to the Liberty Heights Pavilion (Project C23409) to complete the project.




