RE: **Capital Improvement Program for 2005**

Attached is our proposed 2005 Capital Improvement Program. This is a "living" plan, which may be changed depending on needs and public hearing response. The program was reviewed and approved by the Advisory Capital Improvement Committee about a month ago. The plan does not include projects from the Public Works, Fire and Development Departments.

Highlights of the 2005 program are:

- 1) Continue the Interim Street Resurfacing Program. This is where we mill off a couple of inches of old asphalt and place a new two inch surface with a minimal amount of concrete or underground work.
- 2) Another big year for alleys with 14 on the program. All of the alleys shown were requested by Aldermen or residents. We are already listing alleys on our 2006 program.
- 3) Start up of design engineering and right-of-way purchasing for WisDOT sponsored projects along 60th Street and National Avenue.
- 4) Continuation of the sidewalk repair program.
