Re: Recommendation for Changes in Basic Life Support Fees

Recently, a committee of the Milwaukee County Association of Fire Chiefs (MCAFC) reviewed countywide ambulance fees to assure that rates are in line with current economic issues, Medicare reimbursements, and to measure consistency across the county. Besides the committee activity, I asked Life Quest, Inc., our Basic Life Support billing agent, to determine whether we could improve revenue by changing ambulance fees.

Basic Life Support (BLS) fees are determined by the local municipality, while Advanced Life Support (ALS, "Paramedic") rates are determined by the Intergovernmental Cooperation Council (ICC, comprised of mayors and village presidents). The 2017 ALS rates have been approved by the MCAFC and ICC in October.

For your review, I've attached a spreadsheet with Life Quest's suggested rates, MCAFC's average rates, and Kris Moen and my recommendations on rate changes. If we implement the rate changes as suggested, Life Quest has anticipated that the City could receive approximately \$31,411.28 in additional revenue based upon our transport and treatment history.

I am suggesting you approve the rates as presented in the corresponding resolution.

I would like to point out there is one increase, recommended by Life Quest, that I'm suggesting not be increased. We have never charged a "BLS Service and/or Treatment without Transport (Resident)" charge and I'm suggesting we continue to keep that rate at \$0.00. My logic for this is our residents pay taxes that support the EMS services we provide and some level of service should be covered by those dollars. When a resident isn't sure if an ambulance is needed or not, I'd like them to be able to error on the side of their safety and call without fear of receiving a bill. In addition, this charge is not covered by Medicare or Medicaid, with 70% of our collections coming from these sources, meaning those least able to pay for this charge will be most impacted by this out of pocket cost.

The last ambulance fee change in our city was implemented in 2009.

I've discussed these rate changes with Kris Moen, Interim Finance Director and we are in agreement on the recommended increases. I will be available to address any of your concerns. Please feel free to contact me with any questions you may have.
