Upon deliberation and consideration of the evidence presented at the hearing held on February 26, 2008, the Committee finds:

FINDINGS OF FACT:

- 1. That the allegations in paragraphs 5, 6, 7, and 8 of the amended complaint were admitted by Deborah A. Daniels and are true;
- 2. That Deborah A. Daniels is a habitual law offender;
- 3. That the conduct of Deborah A. Daniels described in Paragraphs 5, 6, 7, and 8 of the amended complaint substantially relates to the alcohol beverage licensed activity contrary to Wis. Stat. § 125.04 (5)(b);
- 4. That in particular, the three operating while intoxicated convictions, the disorderly conduct conviction, and Deborah A. Daniels' obstructive and resistive conduct toward West Allis Police Officer Caleb Porter are deemed to be contrary to Wis. Stat. § 125.04 (5)(b).

CONCLUSIONS OF LAW:

1. That the evidence submitted at the hearing constitutes a sufficient basis to not renew the bartender's license of Deborah A. Daniels.

Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Bartender's License of Deborah A. Daniels, No. 09-329, not be renewed.
