WHEREAS, WHEREAS, Diane & John Knecht requests from the City of West Allis a certain Privilege for Encroachment Beyond the Lot Line and Within Public Street Right-of-Way consisting of the installation of east side entrance stairs on the property located at 5801-03 W. 
