The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of January.

#### **Incident reports:**

# Case # 14-00006, 01/01/2014, at 0215 hrs – 6827 W. National Av. GR's National Pub

On 01/01/2014, at approximately 0215 hrs., Officers responded to 6827 W. National Av, GR's National Pub, regarding a check on the welfare of a female party and her 13 year old son. Donna Owen stated she was at the tavern with her son, waiting for the bus for approximately two hours. Donna stayed in the bar and consumed alcohol. The temperature was in the single digits and her son was only wearing a hooded sweatshirt. Officers gave Donna and her son a courtesy ride home.

### Case # 14-327, 01/09/2014, 2310 hrs., - 1309 S. 60 St, Remedy Bar

On 01/09/2014, at 2310 hrs., Officers responded to the Remedy Bar, 1309 S. 60 St for a report of an assault. Raymond O. Abel admitted to pushing his intoxicated friend, Donald Maxwell, during an argument. Donald fell and hit his head on the floor, causing a laceration to his head. Raymond was arrested for substantial Battery. Raymond was booked and ordered to the District Attorney's Office. The DA issued Raymond Abel with misdemeanor Battery.

On 01/14/2014, at 0057 hrs., Officers responded to Czar's Bar, 6901 W. Beloit Rd for a report of a male breaking a gaming machine in the bar. On 01/15/2014, at 0206 hrs., Officers responded to the Walleye Saloon located at 8824 W. Becher St. for a Sexual Assault. The victim, who was the bartender at Walleye Saloon, was brought to the West Allis Police Department where she gave details of a being sexually assaulted by a patron inside the tavern. The bartender did not wish to pursue the matter.

On 01/26/2014, at 0151 hrs., Officers responded to Las Palmas, 1901 S. 60 St for a Trouble Call. Numerous parties were fighting and causing a disturbance. David was also cited for battery and was found to be on Probation. A hold was placed on David by the Department of Corrections, all others were issued municipal citations, booked and released
