To the City of West Allis:

I have been retained by Juan J. Corona and Miriam E. Corona, individually, and as parents of Richard Ortega, III, Juan Corona, Jr., Damien Corona, and Ariel Corona, who sustained injuries and damages in an incident which occurred at their residence located at 6101 West Mitchell Street, West Allis, Wisconsin, on June 21, 2015.

It is my understanding that officers of the West Allis Police Department, including, but not limited to Trevor Rivera and Richard Krueger, entered the Corona residence and used, among others, excessive force and violated the civil rights of all of my clients for an unknown reason, and may have entered the wrong address as overheard by my clients.

It is my understanding that my clients all were handcuffed for no apparent reason and all suffered physical and emotional injuries as a result of the outrageous and unwarranted conduct of the West Allis Police Department and its many officers who came to their residence.

Kindly advise the undersigned whether or not the City carried a policy of liability insurance at the time of this incident and, if so, the name of the company and the policy number, or, in the

alternative, turn this letter over to your insurance company so that they can contact me directly and avoid you any further inconvenience in connection with this matter.

In addition, I am, by this letter, hereby requesting that you provide me with any and all records, including, but not limited to, warrants, investigations and reports generated by your officers concerning this incident under the Open Records Laws of the State of Wisconsin.

I trust I have adequately summarized my position and you will acknowledge this letter of retainer and, in addition, provide me with a full and complete copy of all records concerning this matter.

In addition, please construe this letter as a formal notification of my attorneys' lien rights under the Wisconsin Statutes.
