**RESOLUTION ACCEPTING THE PROPOSAL OF N&S TOWING, INC. FOR  
PROVIDING VEHICLE TOWING AND STORAGE SERVICES FOR THE CITY OF  
WEST ALLIS**

**WHEREAS**, the Finance/Purchasing Department duly advertised a request for proposals for providing vehicle towing and storage services for the City of West Allis, and the proposals received, as shown on the attached bid report, were reasonable; and,

**WHEREAS**, the Public Works Department and Police Department reviewed all four proposals, rated each vendor, and selected N&S Towing, Inc. as the most capable service provider to tow and store vehicles, including tows requested for snow emergencies; and,

**WHEREAS**, the Common Council deems it to be in the best interests of the City of West Allis that the proposal of N&S Towing, Inc. be accepted.

**NOW THEREFORE**, be it resolved by the Mayor and Common Council of the City of West Allis that the proposal dated November 25, 2025, submitted by N&S Towing, Inc. for providing vehicle towing and storage services for the three-year period of January 20th, 2026 through December 31st, 2028, with a possible three-year extension upon mutual agreement, in accordance with City of West Allis RFP # PD-25019 is accepted.

BE IT FURTHER RESOLVED that the Finance/Purchasing Department is authorized to enter into a contract for these services.




