

SUMMARY

Ofc. Primising reports:

On 03-01-14 at 2208hrs, officers responded to 6500 Bar, 6500 W. Greenfield Ave. for a report of a disorderly subject inside the bar. Contact was made with Danial Charles Blise, M/W 06-20-66, who was attempting to fight other patrons. Blise was immediately uncooperative with officers and refused to follow commands. Blise was directed to the ground, after attempting to grab the keys that were just removed from his possession by officers. Blise continued to resist by kicking, pulling his arms beneath his body, and attempting to bite and spit on officers. Blise was transported to AWAMC for facial injuries. He had several final commitments through Greendale and was issued DC and Resisting Officers citations. Local court date 04-07-14 at 0830hrs.

NARRATIVE

INITIAL CALL

On 03-01-14 at 2208hrs, officers responded to 6500 Bar, 6500 W. Greenfield Ave. for a report of a disorderly M/W subject, approx. 50yoa, wearing a bandana inside the bar.

CONTACT WITH DANIAL C. BLISE

Upon arrival, officers made contact with this subject, Danial C. Blise, M/W 06-20-66, seated at the bar, who matched the description provided. As I began speaking with Blise, I observed he had a large ring of keys balled up in his hand. For officer safety reasons, I advised Blise to put down the keys several times, before he complied. I slid the keys behind me on the top of the bar, several feet out of Blise's reach. I began asking Blise questions regarding the events in the bar, which Blise would not answer or acknowledge. Based on Blise's thick, slurred speech, red glassy eyes, and lethargic movements, it appeared he was heavily intoxicated.

RESISTING OFFICERS (M.O.R.A.)

While I spoke to him, Blise suddenly lunged in my direction, stating, "Give me my keys." Blise lunged so that he was partially on top of the bar, and reached past me, grabbing the keys I had removed from him. I ordered Blise to "drop the keys" twice without cooperation, before I forcibly removed them from his hand. As I grabbed his right arm, I could feel resistive tension in his forearm, so I pulled the keys from his hand and pulled his arm away from the bar area and towards the ground. Due to his intoxicated state, Blise fell from the bar stool, to the ground. Blise immediately became resistive with officers, pulling his arms beneath his body, out of view from officers. Blise had not been searched, but I had initially observed he was wearing a belt. As it was unknown whether or not he had any weapons, Ofc. Clark and I immediately engaged him and attempted to gain control of his arms.

Both Ofc. Clark and I gave Blise commands to "put [his] hands behind [his] back" and "stop resisting;" however, Blise refused to cooperate. I attempted to gain control of Blise's right arm by utilizing compliance holds. I observed a small pouch on the right side of his belt, well within his reach. I believed this small pouch may have contained a weapon. I delivered one knee strike to Blise's right side, without effect, as he continued to resist. Blise continued to thrash his upper body and legs, and at one point attempted to push himself off of the ground. Ofc. Clark delivered focus strikes, while attempting to gain control over Blise's

left arm. During the struggle, I called for additional officers to respond.

Eventually I was able to secure Blise's right side and Ofc. Clark his left. I then tactically handcuffed Blise and immediately began to search his person. Inside the small pouch on his waist, I located an approx. three inch folding knife. I observed Blise had some injuries to his face from the incident and called for an ambulance to respond to our location. Blise did not complain of any injury, despite bleeding from his face and forehead. Even after being handcuffed, Blise tried to roll on to his side and kicked at officers. Ofc. Clark stated Blise attempted to bite him at one point.

Throughout the incident, Blise repeatedly told officers he was going to "kill" us and made several other threats of bodily harm. Blise called me a "cunt" over a dozen times and used extensive profanity when yelling at the police. Blise bragged to officers about physically assaulting several Milwaukee Police Officers in a past incident, and advised he could do the same to us. He also repeatedly yelled about being a Marine and stating he knew how to kill people.

Blise continued to be resistive while inside the ambulance, kicking his feet and struggling to remove them from the cot straps. Blise also began to spit at officers and had to be restrained. I provided Ofc. Clark with a spit hood from my squad, which was placed on Blise's head for the duration of the ambulance ride to Aurora West Allis Medical Center.

MEDICAL TRANSPORT

Due to minor injuries to his face, Blise was transported to AWAMC for treatment. At the hospital, Blise was placed in four-point restraints and yet continued to be uncooperative. Third shift officers responded to remain with Blise for the duration of his treatment.

CASE DISPOSITION

Danial C. Blise caused a disturbance inside the 6500 Bar, when he attempted to start fights with several patrons. Upon officer arrival, Blise became resistive, causing officers to use physical force. Blise was conveyed to AWAMC for minor injuries and issued two municipal citations, with a scheduled court date of 04-07-14 at 0830hrs.

NARRATIVE

Cpl. J. Cerqua reports:

INITIAL COMPLAINT

On 03/01/14, at 2216 hrs, I responded to the 6500 Bar, 6500 W Greenfield Ave, to assist Officers Primising and Clark with an uncooperative and resistive subject.

OFFICER OBSERVATIONS

Upon arrival, I discovered Officers Primising and Clark had a subject handcuffed on the ground inside the business. The subject was lying on his stomach, and Officer Clark was securing his head and upper body on the ground while Officer Primising was securing his lower legs. The subject, later identified as Danial C. Blise, M/W 06/20/66, was yelling profane language, which included, "Fuck you," and, "I'm going to fucking kill you." Blise was also repeatedly yelling that he was a Marine and to get off of him.

I attempted to help secure Blise on the ground, as he had been thrashing his body slightly from side to side, when he kicked legs outward. Blise did not make contact with Officer Primising or myself during his kicking, but his movements appeared to be consistent with him intentionally trying to strike us. Based on his resistive behavior, and to avoid a possible assault on myself or other officers, I pinned and secured both of Blise's legs on the ground.

Officers requested to have a rescue respond to our location for facial injuries to Blise, which were caused during his struggle and resisting. Rescue personnel from WAFD arrived a short time later, and Blise was secured on a stretcher. While in the back of the rescue with Blise and Officer Clark, Blise threatened Officer Clark several times. Blise looked at Officer Clark and stated, "I will remember your face and I will fucking kill you!" Blise

also threatened, "I will bite your balls off," to Officer Clark and threatened to eat him.

During my contact with Blise in the rescue, he also made a sudden jerk forward with his upper body and head, and attempted to headbutt Officer Clark. However, the restraints from the stretcher prevented Blise from doing so, and Officer Clark secured Blise's upper torso and head on the stretcher to avoid an assault.

STATEMENT OF MICHAEL T. BOOS

Once Blise was secured in the rescue, I made contact with Michael T. Boos, M/W 09/18/63, who was a patron inside the tavern. Boos stated he arrived at the 6500 Bar on 03/01/14, at approximately 2145 hrs, and Blise arrived at approximately 2200 hrs. When Blise entered the tavern, he saw the Marine symbol on Boos's sweatshirt and began telling him that he was a Marine. Boos told Blise he was not a Marine, but that his son was, and they shook hands. Blise then moved down the bar and away from Boos.

Boos stated Blise suddenly began yelling "Mother fucker!" several times, each time getting louder. Boos believed Blise was yelling it towards him, but he did not know why and had his back turned to him at the time. Blise was told to quiet down and relax, and Blise apologized for his behavior.

A short time later, a black male subject entered the tavern to sell candy. Boos stated the subject worked for a church, and Blise immediately began yelling at him and challenging him to a fight. Blise then stood in the doorway to the tavern, preventing the subject from leaving. Blise kept yelling at the subject, "I'm a bad mother fucker! I'm a Marine!" and continued to threaten that he would "kick his ass."

The male subject did not want to fight Blise and only wanted to leave the tavern. He pulled out pepper spray and began shaking it in his hand, telling Blise not to fight. Blise eventually moved out of the way and the male subject left the tavern. Boos does not know who the male subject was and could not provide any information on him.

Boos stated he does not know who Blise is and has never met him before. It appeared to Boos that Blise was trying to pick a fight with "anyone and everyone," and stated he was definitely causing a disturbance inside the tavern by yelling, swearing, and threatening to fight people. Boos stated Blise had also told the female bartender she had a "nice ass," and the bartender called the police to report his (Blise's) behavior.

Boos stated once the police arrived on scene (Officers Clark and Primising), they told Blise to put his keys down on the bar. Blise subsequently placed his keys down, but Boos believed he tried to pick them back up as officers

yelled at him twice to "put them down." Blise was being uncooperative with the officers, and they took him down to the ground where they tried to handcuff him. However, Blise was being resistive and would not give officers his arm so they could handcuff him.

Boos did not know what else had happened during Blise's struggle with the police, but stated Blise kept making "stupid talk" with the officers.

NARRATIVE

Officer Kielley reports....

Source of Activity...

On 03/01/14 at approximately 2208 hrs. I responded to the "6500 Bar" at 6500 W. Greenfield Ave. after officers already on scene (handling a belligerent patron) requested additional officers respond to assist.

Officer observation...

When I arrived on scene, I observed officers attempting to restrain a male party on the ground just in front of the door. The male party was later identified as Danial C. Blise, M/W, 06/20/66. Blise head was being secured by Officer Clark and his legs secured by Cpl. Cerqua. Blise was swearing at officers and stating "I should beat your ass, I'll fucking kill you!" He also kept repeating that he was a Marine and demanded officers get off of him. Blise was trying to kick at officers and kept yelling profanities.

Witness statement...Nita Louise Tonya Barry, F/W, 08/01/83...

Barry advised she was the bartender during this incident. She advised she works just about every night of the week at the 6500 Bar. Barry advised that at approximately 1800 hrs., Blise came into the bar. Barry had no problems

with him at that time. She advised Blise had left the bar at 1830 hrs. and went across the street, presumably to another bar, for about an hour.

Blise came back and he was pretty intoxicated. He asked for a beer and Barry provided him with one. Barry stated that Blise struck up a conversation with the other patrons at the bar and kept stating that he was a Marine. Blise was challenging the other men to an arm wrestling match, to which, they declined. Blise kept making off the wall comments like he was a "jar head" and that no one was going to fuck with him. He also kept telling Barry she had a "nice ass" to the point it was making her feel uncomfortable.

Barry told Blise he was going to have to leave because he was causing a disturbance in the bar but advised he could finish his beer first. A male party came in the bar from a church and was trying to sell the bar patrons candy. Blise started making rude comments to the man and challenged him to a fight. The man wanted nothing to do with Blise and tried to leave, but Blise was blocking his path. The man dropped his stuff and pulled out a can of pepper spray and started to shake it. Blise eventually moved out of the man's way so he could leave. Barry stated that at this point, she had enough of Blise and called the police.

Barry stated when police arrived, Blise had keys in his hands and the officers told him to put the keys down. Blise put the keys down and slid them away from him. When the female officer (Primising) tried to pick the keys up Blise grabbed them from her hands. The officers grabbed Blise arms in an attempt to restrain him, but he kept fighting with them.

Barry advised that as officers were trying to restrain Blise, he was pulling away from them and saying he was a Marine. Once on the ground, Blise was kicking at Officer Primising and pulling away from officers. Barry stated that Blise could not understand why officers were hurting him.

Barry stated Blise had only been in the bar for about twenty minutes before she had called police on him. Barry did not recall ever seeing Blise in the bar before today.

Witness statement...Matthew T. Kazel, M/W, 07/08/83...

Kazel stated Blise came into the bar at approximately 1930 Hrs. Kazel said Blise was nice at first talking about the military. Blise had asked if Kazel and another guy if they were in the Marines. Kazel advised him he was in the Army and the other guy stated someone in his family was in the Marines.

A "church guy" came into the bar trying to sell some candy. For some reason, this got Blise all worked up. Blise kept saying the guy smoked weed. The guy selling candy tried to leave but Blise would not let him. The guy

eventually grabbed some mace and started to shake it. The guy told Blise he would spray him if he didn't let him go. Blise moved out of the way and sat down. The man selling candy then left.

Kazel stated that Blise sat down then started saying "You guys don't know shit about the Marines". The bartender told Blise he could finish his beer but then he would have to leave. Blise started to make inappropriate comments to the bartender saying she had a nice ass. Blise started to ask Kazel if he wanted to arm wrestle and was just in general causing a disturbance trying to instigate a fight. Kazel stated he advised the bartender to call the police as Blise was getting out of control.

Kazel stated when the police arrived, Blise was holding his keys. Officer Primising told him to put the keys down. Blise put the keys down and slid them away from him. When Officer Primising tried to take the keys, Blise grabbed them away from her. Kazel stated the officers grabbed Blise's arms and said he need to listen. Blise ripped the keys from Officer Primising and the officers put him on the ground. Kazel stated that Blise kept trying to kick Officer Primising. Kazel stated that Blise kept fighting with officers. He kept yelling that he was a Marine and would kick their asses.

Kazel stated he goes to this bar almost every night and he has never seen Blise there before.

I noted two patrons sitting on the southwest side of the bar and the female bartender was behind the bar.</p> <p><u>CONTACT WITH SUBJECT - DANIAL BLISE</u></p> <p>Officer Primising initiated contact with Blise, who was holding a large ball of keys in his hand. Blise, was obviously intoxicated, smelled of an alcoholic beverage and was slurring his words as he spoke. Blise was unsteady on his feet as well.</p> <p>Officer Primising told Blise to put his keys down several times and after he finally put them down, he lunged for them. Officer Primising attempted to keep Blise away from his keys. He pulled away from her and fell to the ground. Blise immediately put his hands under his person. Blise would not remove his hands from under him, and when I could grasp one of his hands, he would place the other under him. Blise had not been searched as of this time, and I feared he may have a weapon on him, as his hands were continually in the area of his waist. I told him to give me his hands and stop resisting, however he did not comply with my request.</p> <p>I delivered several closed fist blows to Blise's abdomen, with no response from him. At some point during the scuffle, Blise began to push himself up off the ground and I pushed him back onto the floor. Blise struck his head on the floor at this time. Officer Primising called for additional units to respond to our location as we still did not have Blise secured. I continued to attempt to get Blise's hands behind his back and he continued to resist.</p> <p>I delivered more blows to Blise's mid section and I finally received a response from him by him releasing some of the tension on his arms. I was able to get one of his hands behind his back for Officer Primising to apply handcuffs, as she had control of his other hand.</p>

After Blise was handcuffed, he yelled he was a Marine and we should not be treating him like that. I thanked him for his service and told him I needed him to relax. Blise responded by trying to kick Officers Primising and Cpl. Cerqua who had just arrived on scene. Blise thrust his head towards my hand which I had removed from his back. I believed he was trying to bite my hand. I secured his head against the floor and Officer Primising and Cpl. Cerqua secured his legs. I told him again to relax, and he continually thrust his body and he tried to free himself from Officers. Officers called for a rescue to respond to tend to Blise.

Blise had to remain secured on the ground until WAFD Rescue responded to the scene. He was continually resistive, with tension in his body and he would also thrust his legs and torso in attempt to escape.

MEDICAL TRANSPORT

When Blise was finally placed on a cot and inside the ambulance, he told me several times he was going to, "Bite your fucking balls off." I told him to relax and he continued to thrust and try to free himself from the cot. Blise, when I was holding him to the cot thrust his face forward again and tried to bite me. I held his head away from me and secured his head to the cot, with minimal pressure. At this time, Blise began to spit. I told Officer Primising to get me a spit hood and when it was delivered, I placed it on Blise's head.

HOSPITAL - MEDICAL CLEARANCE

Blise tried one additional time to bite me at Aurora West Allis Medical Center. I secured his head against the hospital bed, again with minimal force. At that time, Blise was turned over to third shift officers.

I have been living at 1338 S 65th St for the past 20 years, just 1 house down from the bar at 6500 W Greenfield on the east side of 65th St.. The multiple police reports over the years should prove reason enough for you NOT to renew this liquor license, but I will summarize the the ongoing nuisance of this business for the past many years.

- Scott Jesion IS currently an active player in the operation of this business (when he is not incarcerated), and has been prior to and since taking over again from his lessees, who left approx 1 year ago.
- They are not following the directives ordered by the licensing committee (as printed in the West Allis NOW 3-18-2009):

.....More recently, Peter Crivello surrendered his liquor license and the new management has promised city officials that Scott Jesion, who previously managed the bar, would no longer be involved with the tavern. Subsequently, the Common Council last night granted a liquor license to Jill Huennekens, who works part-time at Scotty's and also has experience at the Chancery in Wauwatosa. But the liquor license committee also issued a stern warning that Huennekens will be "under the microscope." "Right now, you're getting your warning," Alderman Gary Barczak told her at the committee meeting. "We're putting faith in you, we're putting our trust in you and we believe ... you're going to run a good ship."

- The establishment has no respect for neighbors as to noise, litter or property upkeep.
- They have no garbage service, and the "grill" aspect of their name/business promise has not been in operation for at least 10 months. They can be considered the stereotypical corner dive bar (with no grill)
- Scotty is seen unloading liquor, beer and ice from his truck into the premises for years now. He does not live there. There are no beer or liquor deliveries made to the premises by distributors.

The 6500 Bar & Grill, Scotty's – or whatever you want to call it is not a good neighbor, never has been and never will be. If this business is indeed "under the microscope", you should be aware of his current and past operations, and your decision should reflect this.

For the Good of the City and the Neighborhood - The City of West Allis Licensing Committee should vote to not renew his license and rid this operation from this city, and close them down for good. You have been extremely lenient, given them many chances, and taken their word throughout all their unkempt promises– but the bottom line is the owner of this license has not kept their part of the deal as stipulated in your past warnings.

If West Allis is indeed taking steps to "clean-up" the city's image, not renewing this license would be a step in the right direction.
