**RESOLUTION TO APPROVE THE TERMS AND CONDITIONS FOR A \$200,000
ECONOMIC DEVELOPMENT LOAN TO NOBLE CATERING MKE, LLC FOR
THE PURCHASE OF 1445 S. 113TH ST. UNDER THE ECONOMIC
DEVELOPMENT LOAN AND COMMUNITY DEVELOPMENT BLOCK GRANT
PROGRAMS**

WHEREAS, Noble Catering MKE, LLC (d/b/a Noble Catering and Events) has applied for a \$200,000 loan from the City of West Allis under the Economic Development Loan Program to support their business relocation to 1445 S. 113th St.; and

WHEREAS, the Economic Development Program reviewed the loan request from Noble Catering MKE, LLC and has determined that the project is eligible for funding under the Economic Development Loan Program; and

WHEREAS, the Economic Development Loan Task Force has recommended approval of an Economic Development Loan for the purpose of completing the project.

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis it approves a \$200,000 Economic Development Loan to Noble Catering MKE, LLC, located at 1445 S. 113th St., as outlined in Exhibit A.

BE IT FURTHER RESOLVED that the City Attorney is authorized to prepare required loan documents, to make any non-substantive changes to the approved documents to effectuate their intent, and to prepare and deliver any other documents necessary to complete the approved transaction.

BE IT FURTHER RESOLVED that the proper City Officers or any of their authorized deputies are authorized on behalf of the City to execute the aforesaid loan documents.

BE IT FURTHER RESOLVED that the Economic Development Executive Director is authorized to modify the terms of the loan agreement or documents if within the original intent of the loan or to help the business to achieve the goals of the loan.

BE IT FURTHER RESOLVED that this loan is funded by the Community Development Block Grant Program.

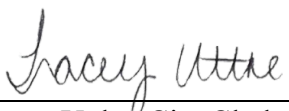

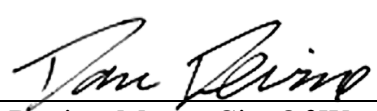
