Richard Law Offices, LLC, present this Notice of Injury to recover for personal injuries sustained by Darius L. Wade in a motor vehicle accident which occurred on November 16, 2021.

On November 16, 2021 at approximately 2:40 p.m., our client, Darius L. Wade, was operating his vehicle southbound on North 60th Street at or near its intersection with West Chambers Street in the City and County of Milwaukee, State of Wisconsin when a City of West Allis Police Department vehicle, being operated by Detective David J. Madden, which was traveling in the same direction, suddenly and unexpectedly began to turn westbound on West Chambers Street in front of Mr. Wade's vehicle, thus causing a collision between the two vehicles.

Our client, Darius L. Wade, sustained injuries in this accident and is still receiving medical care. The amount of his claim is currently unknown.


This claim is being made against the City of West Allis, West Allis Police Department, David J. Madden, and the City of West Allis-City Attorney's Office.


