Side: East

Restriction: No Parking Anytime



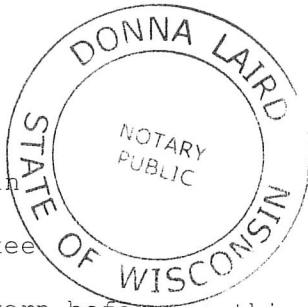


