The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the months of August / September and one incident that occurred on July 29.

#### **Incident reports:**

Case # 12-006596, 07/29/2012, at approx. 0226 hrs – Magoo's Tavern, 8911 W. National Ave.

On 07/29/2012, at 0226 hrs, Officers responded to Magoo's Tavern, 8911 W. National Ave for a report of a fight in progress. Upon officers arrival several parties were observed verbally arguing. Officers' investigation revealed that three individuals were the primary aggressors with this altercation and were cited for disorderly conduct. One of the individual's arrested for D/C was also in possession of THC and was cited possession of marijuana; another individual was observed kicking and punching a vehicle on scene and was cited for criminal damage to property.

Case # 12-007271, 08/18/2012, at approx. 0230 hrs - Dog House Tavern, 1641 S 68 St.

On 08/18/2012, at approx. 0230 hrs, Officers responded to Aurora West Allis Medical Center for a report of a patient who had been physically assaulted. Officers investigation revealed that the victim in the hospital was substantially beaten after leaving the Dog House Tavern (1641 S. 68 St) on Saturday, 08/18/2012. The offenders could only be described as 3 Hispanic males. The victim suffered a fractured jaw that required surgery, and at least two chipped teeth. In addition, a friend he was with was also physically assaulted.

The bartender observed the battery take place outside the tavern and threatened to call the police, but investigating officers don't believe he ever followed through with the call.

# Case # 12-007352, 08/21/2012, at approx. 0049 hrs – Kokopelli's Pub & Grill, 6001 W. Madison St / Remedy Bar – 1309.

On 08/21/12, at approx. 0049 hrs, Officers responded to Kokopellis Pub & grill (6001 W. Madison) & Remedy Bar (1309 S. 60 St) for a report of a fight. Officers' investigation revealed that an intoxicated male individual was causing a problem outside the two bars. This person was told to leave the area and retaliated by pushing a female and tackling the boyfriend of the female; the boyfriend was also punched in the face by the offender. The offender was arrested for Disorderly Conduct and also had a valid warrant with St. Francis P.D.

## Case # 12-007425, 08/23/2012, at approx. 0103 hrs – Stumble Inn Tavern, 6404 W. National Ave.

On 08/23/12, at approx. 0103 hrs, Officer Schweitzer responded to the Stumble Inn Tavern for an anonymous report of an underage person consuming alcohol inside the bar. Officer's investigation revealed that there was an underage female person consuming alcohol in the bar. The female in question provided officers with a fake ID; the photo on the ID looked like the offender, but it was later learned she was using a friend's ID. The offender was subsequently cited for obstructing an officer and possession/consumption of alcohol by a minor. The fake ID's were confiscated.

The bartender admitted she never carded the underage female and was mailed a ticket for procure for/sell/dispense/give alcohol beverage to an underage person.

### Case # 12-007734, 09/02/2012, at approx. 0157 hrs – The Draft Tavern, 9105 W. Lincoln Ave.

On 09/02/2012, at approximately 0157 hrs, Officer Lentz was flagged down by a female individual in front of the Draft Tavern, located at 9105 W. Lincoln Ave. The female reported that she was involved in a physical altercation inside the bar, and she refused to leave. This individual was offered a ride home, but began to yell and create a disturbance; she was subsequently arrested for Disorderly Conduct.

#### Case # 12-007786, 09/04/2012, at approximately 0005 hrs – 57 Bar, 5632 W. Burnham St.

On 09/04/2012, at approximately 0005 hrs, Officers responded to a report of a fight in progress at the 57 Bar (5632 W. Burnham St). Upon Officers arrival the offenders fled the bar. The investigation revealed that a F/W patron physically assaulted the bartender, and the M/W she was with spat in the face of the owner. Both offenders were located by officers and charged with Disorderly Conduct.

#### Case # 12-007893, 09/05/2012, at approx. 1622 hrs - Danny's Lounge, 1900 S. 60 St.

On 09/05/2012, at approximately 1622 hrs, Officers responded to Danny's Lounge to meet with Alcohol, Tobacco & Firearms Agents (ATF). ATF Agents received information that the owner of this business is putting cheaper liquor into more expensive liquor bottles. The business was not open so phone contact was made with the owner (Daniel Seiy); initially, Mr. Seiy agreed to meet with officers at the business, but later said he would not meet officers without his attorney present; his attorney was not available on this date. No entry was gained to the business.

### Case # 12-007896, 09/05/2012, at approx. 1630 hrs - Korbellys Tavern, 7408 W. Walker St.

On 09/05/12, at approximately 1630 hrs, Officers met ATF agents at Korbelly's Tavern, 7408 W. Walker St. regarding a report of the owner purchasing liquor from liquor stores instead of an approved wholesaler. Several receipts were located reflecting the purchase of liquor from non-approved businesses. Approximately 20 bottles of alcohol listed on the receipts were confiscated by ATF Agents. In addition, the owner had slot machines in his business that he was operating illegally. ATF Agents wrote the owner a warning citation for the liquor violation and gave him a verbal warning for the illegal slot machines.

### Case # 12-043854, 09/22/2012, at approx. 0032 hrs – Harry O's Second Base, 6743 W. Lincoln Ave.

On 09/22/2012, at approximately 0032 hrs, Officers responded to a noise complaint at Harry O's Tavern, 6743 W. Lincoln Ave. Officers made contact with the bartender who agreed to turn the volume down on the Karaoke machine.

#### **Tobacco and Alcohol Compliance checks:**

- Fifteen tobacco compliance checks were conducted on Wednesday, September 19<sup>th</sup>, and all businesses were in compliance.
- No alcohol compliance checks were conducted during this reporting period.

#### Violation of Wisconsin Clean Air Act Smoking Ban:
