**RESOLUTION TO GRANT AN EASEMENT FOR WE ENERGIES TO SUPPLY
ELECTRIC SERVICE FOR THE STREETLIGHTING SUBSTATION ON W.
NATIONAL AVE.**

WHEREAS, the City of West Allis, in conjunction with the Wisconsin Department of Transportation, is reconstructing W. National Ave. from W. Lincoln Ave. to S. 108th St. (STH 100); and,

WHEREAS, the City has an electric substation to power streetlighting at approximately the 10100 block of W. National Ave.; and,

WHEREAS, We Energies requires an easement to provide electric service to the substation; and,

WHEREAS, We Energies is the only power supplier in the City; and,

WHEREAS, the City Engineer recommends the City grant the easement for electric services for the streetlighting substation on W. National Ave.

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis that it grants an easement as described in the attached easement document to We Energies to supply electric service for the streetlighting substation on W. National Ave.

BE IT FURTHER RESOLVED that the City Attorney is authorized to make any non-substantive changes to the approved documents to effectuate their intent and to prepare and deliver any other documents necessary to complete the approved transaction.

BE IT FURTHER RESOLVED that the City Engineer is authorized, on behalf of the City, to execute the aforesaid easement agreement.




