WHEREAS, Leon L. Johnson, Purchasing Manager for the City of West Allis, retired on January 5, 2004; and,

WHEREAS, there continues to be a need for someone to coordinate the purchasing/central services of the City until his vacant position is filled; and,


WHEREAS, Leon L. Johnson has indicated his willingness to work for the City as an independent contractor in this regard.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that the attached agreement between the City of West Allis and Leon L. Johnson to serve as an independent contractor for the coordination of purchasing/central services be and is hereby approved.

BE IT FURTHER RESOLVED that the proper City officials are hereby authorized and directed to execute said agreement on behalf of the City.



AGREEMENT

This agreement entered into this 6th day of January, 2004, by and between the City of West Allis and Leon L. Johnson, hereinafter referred to as independent contractor.

- I. The independent contractor shall from January 6, 2004, through March 29, 2004, provide for the coordination of purchasing/central services in the purchase of materials and services for the City of West Allis under the authority of the City Administrative Officer, City Clerk/Treasurer, review purchase requisitions, proposal requests, purchase orders and contracts, and execute contracts as purchasing agent in the acquisition of goods and services in compliance with the policies and ordinances of the City of West Allis.
- II. The fee for said services as described in Section I of this agreement shall be \$2,500.00/week (five working days).
- III. The City of West Allis and the independent contractor mutually agree that the method of payment shall be in accordance with the terms as set forth herein and shall be the entire sum payable to the independent contractor within fifteen days of the end of each calendar week for which services have been performed.
- IV. The City of West Allis and the independent contractor mutually agree that the independent contractor described herein is not an employee of the City of West Allis. Furthermore, the City of West Allis and the independent contractor mutually agree that the City of West Allis shall not be held liable or responsible for any benefits including vacation time, sick pay, unemployment benefits, worker's compensation benefits, social security tax, insurance, or pension benefits that may be incurred on behalf of the independent contractor, employees, agents, or assignees.
- V. The City of West Allis and the independent contractor mutually agree that this agreement shall remain in effect through March 29, 2004, or until terminated by mutual agreement and thereafter under the same terms and conditions set forth herein on a weekly basis until terminated by written notice from either party.

In witness hereof, the City of West Allis and the independent contractor have executed this agreement as of

January 26, 2004.


