The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of November.

Incident reports:

Call #15-50471, 11/13/2015, 0154 hrs: 9442 W. National Av – Heartbreakers

On 11/13/2015, Officers responded to Heartbreakers for an Assault. Two parties were drinking inside of Heartbreakers, and as they walked outside to leave, one of the parties was punched in the face and knocked unconscious by an unknown male. The male then punched the other party and ran off. It appears these parties got into a verbal altercation with the Offender inside the bar. Video surveillance was viewed. The manager stated the Offender has been seen inside the business on several occasions. Officers advised the manager to call WAPD if he returns. The Offender is still unknown at this time.

Case #15-51788, 11/20/2015, 2230: 9442 W. National Av - Heartbreakers

On 11/20/2015, Officers took an assault report at Heartbreakers. A party stated he was assaulted by a bouncer at the club, who punched him in the face. Another bouncer drove him home. He then went to the hospital and found he had a suffered a fractured bone. The bar manager reported that this party brandished a knife and that is when the bouncer punched him. Video surveillance was reviewed. It appeared the complainant did have a dark object in his hand and then the bouncer punched him, which caused him to fall back. The bouncer then punched him an additional 6-8 times. The other bouncer had to pull him off the complainant. The Officer arrested the complainant for Disorderly Conduct while Armed. He came into the station, was booked, cited accordingly and was released.

Case #15-52211, 11/26/2015, 2141 hrs: 8001 W. Greenfield Av - Tomken's Bar

On 11/26/2015, Officers responded to Tomken's Bar for a Disorderly Conduct Complaint. Officers made contact with a party who appeared to be highly intoxicated. The manager stated the party was kicked out for bothering females in the bar and being too intoxicated. When Officers made contact with the party, he began yelling at officers in an aggressive tone, took his hat off and squared up with Officers. He was arrested for Disorderly Conduct, booked, cited and was driven home (due to his intoxicated state).

Tobacco and Alcohol Compliance checks:

Case #15 -50318

On 11/11/2015, the West Allis Police Department conducted 10 tavern checks at randomly selected West Allis Taverns that have a license to serve alcoholic beverages. The check was completed through the use of a 20 year old male who entered each tavern and attempted to purchase a beer without providing identification. Out of the 10 businesses, two asked for the identification and would not provide the beverage without it. Employees and license holders from the eight taverns that did not require identification were issued citations through the mail. Both the employees and license holders were notified about the violation. The following taverns were in violation:
