Attached is the Department Request to Fill Position Vacancies form for a Civil Engineering position. This position is open due to the resignation of Anne Marie Jensen, January 18, 2013. Existing job descriptions will be reviewed and updated as necessary. This opening is consistent with the approved organization plan.

My intent is to advertise for this position with the requirement of obtaining a Bachelor's Degree in Civil Engineering by May 31, 2013. We intend to advertise the opening in the range of Engineer I through Engineer III, but we see a benefit in including candidates graduating in May of 2013.

Civil Engineer, Level I, II or III (depending on qualifications of candidate)

2. Department/Division:

Engineering Division

3. Vacancy Date:

January 18, 2013

4. Vacancy Reason:

Resignation of Engineer III

5. a. What are the specific work responsibilities of the position?

Highly technical, civil engineering work including construction inspection, estimating and municipal design and use of CAD in drafting of engineering plans.

b. How many other such positions exist in this Department?

There are currently 4.5 civil engineers in Department. Under old approved organizational structure, there were 5.5 civil engineer positions.

6. What are the reasons why the position must be filled?

This position is essential for completing the Capital Improvement Program as well as providing the necessary engineering support to the City. Civil engineers are involved in all areas of municipal engineering work.

- 7. What will be the impacts on service functions if the position were not filled?
 - a. Service to the public.

Either the construction schedule would be delayed and/or work would need to be contracted out to an engineering firm at a higher cost. Necessary infrastructure work along with development projects would not be completed on time or within budget. Service to the public would be negatively impacted.

b. Service to staff.

Without this position, Capital Improvement Program work would be delayed and construction work would not be bid in a timely manner. Assistance to other Departments, such as Planning/Development, would be delayed.

8. What is the fiscal impact related to filling this vacancy?

Civil Engineer I:

Salary Range = \$51,875.20-\$58,697.60

Civil Engineer II:

Salary Range = \$62,483.20-\$69,451.20

Civil Engineer III:

Salary Range = \$70,491.20-\$75,088.00

This position is included in the approved 2013 budget at Engineer III level.

9. Remarks/Comments:

This position is a critical in providing adequate, cost effective engineering support to the City.
