#### REGULAR MEETING

#### A. CALL TO ORDER

The meeting was called to order by Chair Czaplewski at 6:00 p.m.

Summons and Complaint in the matter of the complaint against M & W Hospitality, Inc., Mario P. Morgese, Agent for the premises located at 1900 S. 60 St., d/b/a Mario's (2009-2010 Class B Tavern License no. 1091, Dance Hall License no. 1092 and Instrumental Music License no. 1093).

Appearance by Mario P. Morgese and Atty. Andrew Arena. Mr. Morgese said he does not agree with all the allegations in the Complaint. Atty. Arena told the Committee he would like his name stricken from the Summons. He informed the Committee that he is the registered agent for M&W Hospitality, Inc. but does not deal directly with the d/b/a Mario's nor is his name on the license application. He stated he was not here as legal counsel to represent Mr. Morgese. Atty. Merten replied that according to State Statutes it is proper procedure to list the registered agent. Atty. Arena disagreed and asked the Committee to strike his name from the Summons. Chair Czaplewski responded that he would follow the recommendation of Atty. Merten.

Chair Czaplewski informed Atty. Merten that the Committee would like to move forward with the Hearing. Atty. Merten replied she would set up the Hearing dates and provide Atty. Arena with the necessary information. Mr. Morgese inquired how long the Hearing process could take. Ald. Barczak replied it could begin in two (2) weeks to a month, and could last three (3) to six (6) months, with meetings twice a week and possibly on Saturdays. Mr. Morgese stated he would like to work with the License & Health Committee and the City Attorney's Office

rather than have to go through this lengthy process.

He said he has an obligation to his employees and doesn't want to waste the time and money a Hearing would involve. Atty. Merten told the Committee that if Atty. Arena sends a letter to the City Attorney's Office stating he is not counsel for Mr. Morgese, she would be able to negotiate directly with Mr. Morgese regarding the License & Health Committee's recommendations. Ald. Barczak told Mr. Morgese he can work with Atty. Merten after she receives the letter from Atty. Arena stating he is not legal counsel for Mr. Morgese. Mr. Morgese expressed concerns about his legal rights if he does not like the License & Health Committee's recommendations. Atty. Merten informed Mr. Morgese he can hire legal representation at anytime during the proceedings.

Lt. Morrissey advised Mr. Morgese to contact Lt. Benish if he would like some assistance with the problems at his establishment.

Barczak commented that he was particularly disturbed by the fact that the kids knew exactly where to go to sell this merchandise. Ald. Weigel commented that the Police Report states that Mr. Issa knew it was stolen merchandise and he lied to the Police. He reminded Mr. Issa that business owners and license holders need to be honest and cooperative, and form a partnership with the Police. Lt. Morrissey stated there was some trouble about a year ago involving Mr. Issa's brother and cautioned him to monitor his activities. Mr. Issa replied he has installed a security camera that he can watch from his home. Ald. Barczak recommended proceeding with a Summons and Complaint to revoke the Cigarette License.
