Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Mr. Gyros Café & Grill, LLC, as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the chair of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis, which records complainant believes to be reliable and accurate.
- 3. That Mr. Gyros Café & Grill, LLC, is the holder of a Food-Related Permit to sell/serve food under Chapter 97 and 254, Wis. Stat., issued by the West Allis Common Council for the license period beginning July 1, 2009, and ending June 30, 2010.
- 4. That the registered agent of Mr. Gyros Café & Grill, LLC is James Wood.
- 5. That according to the records of the City of West Allis, Mr. Gyros Café & Grill, LLC was assessed a personal property tax in the amount of \$2,123.68 in 2007.
- 6. That according to the records of the City of West Allis, Mr. Gyros Café & Grill, LLC

- was assessed a personal property tax in the amount of \$2,144.36 in 2008.
- 7. That on November 30, 2009, James Wood signed an agreement to pay his delinquent personal property taxes at the rate of \$250.00 per month. See attached Exhibit A.
- 8. That upon signing the agreement, Wood paid \$250.00, but never made the required monthly payments in January 2010 or February 2010.
- 9. That on August 12, 2008, Building Inspector Robert Woodard inspected Mr. Gyros Café & Grill, LLC's property at 10535 West Greenfield Avenue to determine whether the premises were up to code for an occupancy permit.
- 10. That Inspector Woodard found several deficiencies of the premises and sent a notice to Mr. Gyros Café & Grill, LLC to correct those violations. See attached Exhibit B.
- 11. That Mr. Gyros Café & Grill, LLC did not correct the violations, and the city attorney's office issued a summons and complaint for the code violation. See attached Exhibit C.
- 12. That the violations were never corrected, and a default judgment of \$5000 was entered against Mr. Gyros Café & Grill, LLC. See attached Exhibit D.
- 13. That as of today's date, Mr. Gyros Café & Grill, LLC has not paid that outstanding judgment and does not possess an occupancy permit.
- 14. That Mr. Gyros Café & Grill, LLC's failure to pay its personal property taxes, failure to pay its outstanding judgment to the City, and failure to possess a valid occupancy permit substantially relates to the licensed activity and is in violation of West Allis Revised Municipal Ordinances 1.08(9) and 13.33(2) and Wisconsin Statutes §§ 97.30, 254.69 and 254.74, and, therefore, is grounds for non-renewal, suspension, or revocation of its Food-Related Permit.

WHEREFORE, Michael J. Czaplewski, requests that Mr. Gyros Café & Grill, LLC, be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Food-Related Permit of Mr. Gyros Café & Grill, LLC, should be revoked, suspended, or not renewed.

AGREEMENT

This **AGREEMENT** is made and effective as of the date signed below; by and amongst the City of West Allis, hereinafter referred to as "City," and Mr. Gyros Café and Grill, LLC, by registered agent James Wood, hereinafter referred to as "Mr. Gyros."

WHEREAS, on January 1, 2008, the City assessed and levied a 2007 personal property tax pursuant to Chapter 74 of the Wisconsin Statutes against Mr. Gyros in the amount of Two Thousand One Hundred Twenty-Three and 68/100 Dollars (\$2,123.68); and,

WHEREAS, on January 1, 2009, the City assessed and levied a 2008 personal property tax pursuant to Chapter 74 of the Wisconsin Statutes against Mr. Gyros in the amount of Two Thousand One Hundred Forty-Four and 36/100 Dollars (\$2,144.36); and,

WHEREAS, Mr. Gyros is delinquent in paying said personal property taxes along with interest and penalty for a total amount due of Five Thousand Seven Hundred Twelve and 98/100 (\$5,712.98), as of December 31, 2009; and,

WHEREAS, the City's Health Department withheld the issuance of a 2009-2010 health permit to Mr. Gyros until Mr. Gyros had paid said delinquent personal property taxes, interest, and penalty in full; and

WHEREAS, Mr. Gyros seeks to obtain a 2009-2010 health permit for Mr. Gyros as soon as possible so as to not interrupt its business operations for the current year;

NOW, THEREFORE, based upon the foregoing, the City and Mr. Gyros agree to the following:

Mr. Gyros agrees to pay the City for the 2007 and 2008 delinquent personal property taxes, hereinafter referred to as "taxes," along with interest and penalty as calculated through December 31, 2009, on the following terms:

- Mr. Gyros will pay Two-Hundred and Fifty 00/100 Dollars (\$250.00) by December 1, 2009.
- 2. Mr. Gyros will make monthly payments of at least \$250.00 on or before the 30th of each month (except in February, it will be the 28th of the month) until the remaining balance on said taxes is paid in full. The remaining balance shall be paid in full before September 30, 2011.
- 3. All payments made as part of this Agreement shall be made payable to the City of West Allis and either personally delivered or mailed to the West Allis City Attorney's Office, c/o Jenna Merten, 7525 West Greenfield Avenue, West Allis, WI 53214.

4. Mr. Gyros further acknowledges that the 2009 personal property taxes for Mr. Gyros will be due on or before January 31, 2010. Mr. Gyros agrees to pay said 2009 taxes in full no later than September 30, 2011.

In the event that Mr. Gyros fails to adhere to the terms of this **AGREEMENT**, the City reserves its right to immediately revoke any and all health licenses granted to Mr. Gyros, without further notice, at which point Mr. Gyros would no longer be able to legally operate its business within the City of West Allis. In the event that the City takes action to revoke any licenses, Mr. Gyros maintains its right to appeal said revocation to the License and Health Committee of the City of West Allis.

NOTICE **BUSINESS OCCUPANCY PERMIT** BUILDING CODE CORRECTIONS

RE: Occupancy Permit Application for the Property Located at 10535 West Greenfield Avenue

To The Above:

On August 12, 2008, a building inspection was made of the above referenced premises as requested by a Business Occupancy Permit Application. The following deficiencies (with correction information where applicable) are violations of the City of West Allis Revised Municipal Code (RMC) and/or the State of Wisconsin Department of Commerce (COMM) Commercial Building Code and shall be corrected and reinspected for compliance before occupancy of the premises.

- The south exterior exit way between the building and the fence is required to be maintained free of stored materials, tall weeds and other obstructions.
- The rear exit hallway is required to be maintained free of obstructions for a width of at least (36) inches for the entire length of the hallway.
- Common use circulation aisles throughout the kitchen are required to be maintained free of obstructions for a width of at least (28) inches.
- Site landscaping is required to be maintained free of weeds. Dead shrubbery is required to be replaced in accordance with the approved site plan.

OCCUPANCY NOTES: 1. Listed deficiencies shall be corrected and reinspected by the inspector prior to occupancy of the premises. 2. Corrections listed in this NOTICE pertain only to the building inspection portion of the occupancy inspection. 3. Approvals for occupancy are required from the zoning, building, electrical, plumbing, fire, and health inspectors.

The property owner may assume responsibility for the above listed corrections, but this is a matter to be resolved between the tenant and the owner. Ultimately, corrections of code violations are the responsibility of the owner who is hereby informed through this NOTICE.
