RESOLUTION R-2026-5068**

**RESOLUTION TO ACCEPT THE PROPOSAL FROM ARIENS COMPANY FOR
ONE OVIS X 40 RC MOWER FOR \$39,453.96**

WHEREAS, the Public Works Forestry Division is responsible for mowing 12 acres of drainage ditches, storm water retention areas, and sloped terrain throughout the city; and,

WHEREAS, in the fall of 2025 and spring of 2026 multiple rental suppliers of mowing equipment were no longer providing rental services; and,

WHEREAS, Ariens Company has provided pricing for the Ovis X 40 RC mower for \$39,453.96, and the proposal through the Sourcewell National Cooperative has been received by the City of West Allis Public Works Forestry Division; and,

WHEREAS, the Finance Department has determined that this contract meets all desired specifications, and that the proposal received is reasonable; and,

WHEREAS, funding for this equipment was not budgeted or planned for the 2026 fiscal year; and,

WHEREAS, the Department of Public Works has consulted with the City's Finance Department for available funding options for this purchase; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposals of Ariens Company be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposal dated June 5, 2026 by Ariens Company for the sum of \$39,453.96 is accepted.

BE IT FURTHER RESOLVED that funding for this purchase will be charged to Account Number 540-1801-538.70-03.

BE IT FURTHER RESOLVED that the Finance Department is authorized to enter into a contract for the aforesaid equipment.

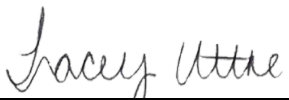

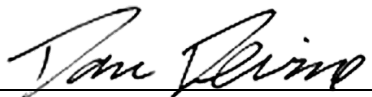
