WHEREAS, a tree and flower planting project and the aforesaid project costs are eligible for Community Development Block grants funds; and ,

WHEREAS, the project involves the planting of trees and flowers for the beautification of low/moderate-income eligible neighborhoods; and,

WHEREAS, the eligible activity area has increased in size as a result of 2000 census statistics; and,

WHEREAS, the Director of Development has recommended approval of the fund transfer.
