

NARRATIVE

CASE INFORMATION

On 01/15/14 approx. 0206hrs. officers responded to the Walleye Saloon located at 8824 W. Becher St. for a sexual assault. Upon arrival other officers were already on scene and PO Carlson was speaking with the victim, Andrea L. Beaumont F/W 02/02/91.

CONTACT WITH BEAUMONT

As PO Carlson was speaking with Beaumont, I asked questions about possible evidence. Beaumont advised that the suspect did not ejaculate and the glass he was drinking out of was cleaned prior to the incident. Other officers were trying to speak with the owner about watching the surveillance video.

I asked Beaumont if she would be willing to come with me to the WAPD to speak further and she agreed. I conveyed Beaumont to the WAPD where I escorted her to the soft interview room.

INTERVIEW OF BEAUMONT

I utilized WAPD recorder and memory card 17-2 and recorded my interview of Beaumont starting at approx. 0106hrs. According to Beaumont, she was bartending at Walleye Saloon when the owner, Andrew P. Janocik M/W 06/29/81, had come into the bar with a group of people at approx. 2130-2200hrs. One of the males was attempting to flirt with Beaumont by making sexual comments, but Beaumont could not remember exactly what was said. Beaumont described the male as 29-30 years old, medium complexion, 6'00" tall with brown eyes and long eyelashes.

There were approx. 8-10 people in the bar with 5 of them being together. While the group of playing darts, Beaumont went out the front door and was having a cigarette with a friend at approx. 2300-2330hrs. She wanted to check on her car due to past problems and walked to the eastside of the building. While on the eastside, the unknown male also walked around the side of the building and pulled down his pants, exposing his genitals. He pulled them back up and walked away. Beaumont could not remember if the male said anything when he did this. He then walked away and went back inside. Beaumont's stated her friend did not see this occur, as she was on the eastside of the building by herself. Beaumont returned to the bar and continued bartending.

The male made other comments to Beaumont which she believed was him flirting with her, but couldn't remember the comments. At approx. 0100hrs. Beaumont was going outside to have another cigarette. During this time there was still approx. 8-9

people still in the bar. Beaumont went into the side hallway, which is a private area that leads to the office and also has a door to the east parking lot, to go into the parking lot to have a cigarette. Prior to getting to the door to get to the outside, the unknown male stepped into the private hallway from the bar area and made a sexual comment to her. Beaumont could not remember what the comment

The male pulled down his pants and said "Just kiss it" and Beaumont replied "No." The male then reached with his right hand and grabbed the back of Beaumont's head, forcing her head to his penis. The male kept his hand on her head continuing to force her to perform oral sex on him. Beaumont stated his penis was in her mouth. Beaumont was scared and unwilling to perform oral sex, but felt pressured. Beaumont stated she didn't tell him no and was scared because she didn't know if he had weapons. He did not display any weapons or threaten her. According to Beaumont she has a hard time saying no to people.

Beaumont was on a lower platform by the exit door on her knees while the male was standing up one step in the hallway. Beaumont performed oral sex for approx. 3-5 minutes before stopping and telling the male that she needed to get back to her job. Beaumont was able to walk away from the male and as she entered the bar, he followed. Beaumont went back to bartending. Beaumont believed the male left right away. She stated it made her feel even worse after he left because she felt

Approx. 30 min. later Beaumont started crying and called a friend who told her to call the owner. The owner told her to call police who received the call at approx. 0206hrs.

CASE DISPOSITION

Beaumont initially indicated that she did not want the male arrested or anything done. After the interview, Beaumont advised she was no sure what she wanted done at this time. Beaumont was provided with a business card and a ride to her residence. She was told to call with further information or questions.

Officer Carlson reports...

INITIAL CALL

On 01/15/14 at approximately 0206 hrs., Officers responded to Walleye Saloon located at 8824 W. Becher St. for a sexual assault.

INITIAL STATEMENT

Upon arrival, I made contact with the victim, Andrea L. Beaumont, F/W, 02/02/91, who was visibly upset. Beaumont stated approximately an hour ago, she was forced to perform oral sex on an unknown M/B.

Beaumont stated while she was smoking a cigarette in the back hallway of the bar, the offender opened the door and said, "you're gonna do this". Beaumont stated the offender again stated, "gonna suck my dick". Beaumont stated she felt pressured into performing oral sex. Beaumont stated the offender did not ejaculate. Beaumont stated there was not a weapon involved.

I asked Beaumont why she did not yell for help or try to get away and she stated she did not know. I asked Beaumont why she did not leave the bar through the back door, and she stated she did not know. I asked Beaumont why she did not tell any of the patrons in the bar what had occurred and she stated she did not feel comfortable asking for help.

Beaumont stated she contacted the owner, Andrew P. Janocik, M/W, 06/29/81, approximately an hour after the incident occurred. Beaumont then contact WAPD because she was instructed to do so per Janocik. Beaumont did not know why she did not contact the Police department after the incident had occurred.

offender left approximately an hour and a half after he arrived at the bar. Beaumont stated the offender drank ketel one and red bull but did not have a bar tab. Beaumont described the offender as M/B, skinny and wearing a grey sweatshirt.

CONTACT WITH ANDREW P. JANOCIK

Officers waited on scene until Janocik arrived. Upon his arrival, I spoke to Janocik and asked him if he was at the bar this evening. Janocik stated he arrived at the bar between the hours of 2200 and 2230. Janocik came to the bar with a group of basketball players he is on a team with. Janocik left the bar at approximately 2300 hours and went home.

When Janocik left, he stated there were approximately 5-10 people still in the bar including the basketball players. Janocik was unable to provide me much information about the basketball players names because he just joined the team. Janocik contacted one of the individuals, and got the phone number for Warren (414-940-7633) who was at the bar this evening. Janocik attempted to contact Warren by telephone and was unsuccessful.

STATEMENT OF CONTACT - CHARLENE THOMAS

I spoke with Charlene Thomas, who advised me that she is a friend of the victim. Thomas stated she received a phone call from the Andrea referencing an incident that happened at the bar that was sexual in nature. Thomas stated she came out to the business to meet with Andrea to see what she could do to help her out. Thomas stated that Andrea told her she was in the back hallway when a male she did not know came into the back hallway after her.

Thomas stated she did not receive a lot of specific information about what happened but Andrea advised her that she was forced to perform oral sex on the male. Thomas stated Andrea told her that she was alone with the male when the incident occurred. Thomas stated that Andrea called her after it occurred.

On the above date and time Brice Powell came into the station and requested to speak to someone about this case. After speaking with Lt Johnson, she advised to get a brief statement from Brice and a Detective would interview him at a later date.

STATEMENT BY BRICE POWELL...

Brice stated that he plays basketball with the owner, Andrew, and some other friend's from The Walleye Saloon located 8824 W. Becher St. He stated that they played basketball on 01/14/2014 at about 2100 hrs. and then afterward went to Walleye's. Brice said that while at the bar he and the bartender Andrea were talking along with everyone else at the bar. Brice I.D. some of the other people as Warren, Lindsay and Barret.

Brice said that while at the bar, Andrea propositioned to perform oral sex on him for money. Brice said that he told Andrea "no, I don't do that". Brice said that they continued to drink at the bar and during that time Andrea kept telling him that she thought he was good looking and wanted to give him oral sex. Brice said that at one point Andrea asked him to go in the back room to have a smoke.

Brice said that while they were in the back room Andrea was rubbing up against him and bared her breasts. Brice said that while he was smoking his cigarette, Andrea unzipped his fly and performed oral sex on him. Brice said that it was only for a short period and then she stopped.

Brice said that afterward they both returned to the bar area where they all continued drinking and talking, including Andrea. Brice said that when he heard from the bar owner, Andrew, on 01/15/2014 that Andrea filed a complaint, Missing wanted to come into the station to speak with spinging, and gings

ATTEMPTING TO CONTACT ANDREA

On 01/17/14 at 2120 hrs, I attempted to make phone contact with Andrea. I left a voice mail message asking her to call me back.

At about 2100 hrs, I went to the Walleye Saloon and spoke to a bar tender by the name of Krissa. She stated that Andrea was not working tonight and that she believed that Andrea was taking some vacation time due to the assault incident. Krissa stated that otherwise, Andrea would work Monday from 1400-1900 and Tuesday from 1900 until closing. I gave Krissa a copy of my business card and asked her to have Andrea call me when she saw her.

I then went to 10230 W Lincoln Ave in an attempt to locate Andrea. I received no answer at the door. I left a business card with a note asking Andrea to call me.

CONTACT WITH ANDREA

At about 2200 hrs, I received a call from Andrea. She stated that she received my voice mail message and was returning my call. Andrea stated that she did not just want to forget about the incident but that she was not sure exactly what she wanted to do about it. She asked that I give her a little time to think about the situation. I advised her that I would call her back on Tuesday.

On 01/21/14 at about 1650 hrs, I made phone contact with Andrea. She advised me that she did not want to press charges and felt that since she was not physical harmed, she could deal with the situation through counseling. She also stated that the owner of the bar told her that the video showed that she was drinking a lot and she felt discouraged by this. I advised Andrea that a crime was committed and that she did not have to be physically harmed for the police to take an interest in her case. I advised her that if she was considering counseling, she was in fact harmed. Andrea stated that she wanted more time to make a decision and wanted to talk to her parents first. She stated that she would call me tomorrow. I advised Andrea that I could have our Victim Advocate contact her. She stated that she would like that and asked me to make the referral. I gave her information to Holly Stevens Victim Advocate.

On 01/28/14 at 1126~hrs, I attempted to make phone contact with Andrea. I left a voice mail message asking her to call me back.

CASE INFORMATION

On 01/15/14 approx. 0206hrs. officers responded to the Walleye Saloon located at 8824 W. Becher St. for a sexual assault. Upon arrival other officers were already on scene and PO Carlson was speaking with the victim, Andrea L. Beaumont F/W 02/02/91.

CONTACT WITH BEAUMONT

As PO Carlson was speaking with Beaumont, I asked questions about possible evidence. Beaumont advised that the suspect did not ejaculate and the glass he was drinking out of was cleaned prior to the incident. Other officers were trying to speak with the owner about watching the surveillance video.

I asked Beaumont if she would be willing to come with me to the WAPD to speak further and she agreed. I conveyed Beaumont to the WAPD where I escorted her to the soft interview room.

INTERVIEW OF BEAUMONT

I utilized WAPD recorder and memory card 17-2 and recorded my interview of Beaumont starting at approx. 0106hrs. According to Beaumont, she was bartending at Walleye Saloon when the owner, Andrew P. Janocik M/W 06/29/81, had come into the bar with a group of people at approx. 2130-2200hrs. One of the males was attempting to flirt with Beaumont by making sexual comments, but Beaumont could not remember exactly what was said. Beaumont described the male as 29-30 years old, medium complexion, 6'00" tall with brown eyes and long eyelashes.

There were approx. 8-10 people in the bar with 5 of them being together. While the group of playing darts, Beaumont went out the front door and was having a cigarette with a friend at approx. 2300-2330hrs. She wanted to check on her car due to past problems and walked to the eastside of the building. While on the eastside, the unknown male also walked around the side of the building and pulled down his pants, exposing his genitals. He pulled them back up and walked away. Beaumont could not remember if the male said anything when he did this. He then walked away and went back inside. Beaumont's stated her friend did not see this occur, as she was on the eastside of the building by herself. Beaumont returned to the bar and continued bartending.

The male made other comments to Beaumont which she believed was him flirting with her, but couldn't remember the comments. At approx. 0100hrs. Beaumont was going outside to have another cigarette. During this time there was still approx. 8-9
