I am 67 years old, on medicare and medicare complete.

I take care of my 22 year old grandson, Mark Walker, who has some mental problems due to past abuse by his black father and his black side of the family.

His mother died from breast cancer when he was 15 years old.

He has been a ward of the court in ~~xxxxx~~ California and has also been in Mental Wards in California, Utah and Maryland.

I do not know ~~xxx~~ how to get medical reports from these places.

He has threatened suicide in the ward in California and while in Baltimore, MD had also gone out to do so, but I found his letter and called the police and the found him in time.

He spent 11 days in the ward at Union Memorial.

I have taken care od him for almost 3 years now.

He has been approved for GAMP, but they do not cover Psychiatric help or ~~Psychiatric~~ Psychiatric drugs.

He is on WELBUTRIN XL and ABILIFY.

Both at to expensive for me to pay. He has a PPA card, but Welbutrin Still costs \$84.00 a month and they do not cover Abilify.

I support us on ~~xxxxx~~ \$659.00 a month Social Security. However, after Rent, Electric, Phone and Food there is no way i can pay for his medicine.

~~xxxxxxxxx~~ I have tried several places for help, but to no avail. Without medical insurance none will help/.


I refuse to beleive that there is not any help for him in the City of Milwaukee or the State of Wisconsin.

I need to keep him on his Medication so perhaps he can support and take care od himself.

Even with Medicare and Medicare Complete I cannot pay the Co-pays or my own medication. I do without. With my health in question, i hate to think of ~~xxxxxxxxx~~ what would happen to Mark if i should die.

I am in hopes someone can advise and help Mark.
