**RESOLUTION APPROVING CERTIFIED SURVEY MAP TO ADJUST THE  
EXISTING PARCELS LOCATED AT 1657-73 S. 108TH ST. AND 109\*\* W. MITCHELL  
ST. (TAX KEY NOS. 448-9979-006 AND 448-9979-007)**

**WHEREAS**, Marcus Sengstock submitted a Certified Survey Map to adjust two lots of record located at 1657-73 S. 108 St. (Tax Key No. 448-9979-006) and 109\*\* W. Mitchell St. (Tax Key No. 448-9979-007); and,

**WHEREAS**, with the grant of this Resolution, the Common Council grants approval to record the map and its documents with the Milwaukee County Register of Deeds Office.

**NOW THEREFORE**, BE IT RESOLVED by the Common Council of the City of West Allis, Wisconsin, that the Certified Survey Map being a redivision of All the land of the owner being located in the Part of the North 20 acres of the Southeast 1/4 of the Northeast 1/4 of Section 6, Township 6 North, Range 21 East, in the City of West Allis, Milwaukee County, Wisconsin, bounded and described as follows: Commencing at the Southeast corner of the Northeast 1/4 of said Section 6; thence N 1°10'28"W along the East line of said 1/4 Section and the centerline of S. 108th Street, 690.00 feet; thence S89°21 '18"W, 70.00 feet to a point in the North right of way line of W. Mitchell Street and the point of beginning of lands to be described; thence continuing S89°21 '18"W along said North right of way line, 729.84 feet to the Southeast corner of Parcel 2 of Certified Survey Map No. 6541; thence N 1°12'06"W along the East line of said Parcel 2, 300.05 feet to the Southwest corner of Lot 2 of Certified Survey Map No. 9070; thence N89°21 '32"E along the South line of Certified Survey Map No. 9070, 739.98 feet to the Southeast corner of Lot 1 of Certified Survey Map No. 9070, said point being on the West right of way line of S. 108th Street; thence S 1°10'28"E along the West line of S. 108th Street, 290.00 feet; thence S44°05'25"W, 14.08 feet to the point of beginning.
