**RESOLUTION TO APPROVE THE ACCEPTANCE OF A LAW ENFORCEMENT
DRUG TRAFFICKING RESPONSE GRANT FROM THE WISCONSIN
DEPARTMENT OF JUSTICE IN THE AMOUNT OF \$32,104 FOR THE
INVESTIGATION AND RESPONSE TO DRUG TRAFFICKING**

WHEREAS, City of West Allis Policy P510 requires the West Allis Common Council to approve the acceptance of all grant awards; and

WHEREAS, the Wisconsin Department of Justice provides grant funding to support the drug enforcement efforts of local police departments; and

WHEREAS, the West Allis Police Department has been awarded Law Enforcement Drug Trafficking Response Grant funds from the Wisconsin Department of Justice in the amount of \$32,104 to support drug enforcement efforts; and

WHEREAS, the grant funds are to be used by June 30, 2027, and do not require a local match.

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis that the City accepts the Law Enforcement Drug Trafficking Response Grant award from the Wisconsin Department of Justice in the amount of \$32,104 for the purposes of drug enforcement efforts; and

BE IT FURTHER RESOLVED that the Mayor, City Administrator, and Chief of Police are authorized to take all necessary actions to execute and administer the grant agreement, and to allocate said funds in accordance with the terms of the grant.


