Dear Mayor Devine and Members of the West Allis Common Council,

This letter is being written on behalf of Jennifer Larson, manager of Anchor Bank, located at 7401 W. Greenfield Avenue. It is my understanding that Anchor Bank will open their new facility on a tentative date of Monday, September 8, 2014,, They expect to schedule their “Grand Opening” sometime later. At this same time their current parking lot, former drive-thru building and temporary building will be dismantled and taken away. This leaves their customers with municipal parking only. To help Anchor Bank customers with the transition, Anchor Bank would like to temporarily promote and provide them with designated street parking.

After speaking with Ms. Larson, we discussed the possibility of using 74th Street (south of Greenfield) as designated parking. Parking for four vehicles on the west side of 74th Street would be designated for customer handicap parking and four vehicles on the east side of 74th Street would be designated for Anchor Bank customers only. Anchor Bank will provide the proper signage, but we ask that the City of West Allis Public Works Department provide four “No Parking” signs so they can attach the Anchor Bank Signage. See attached for street map and signage template.

Ms. Larson stated that the parking restriction on 74th Street would be in effect for approximately six weeks. After that time, the signs will be eliminated and Anchor Bank customers will use the parking behind the new facility.

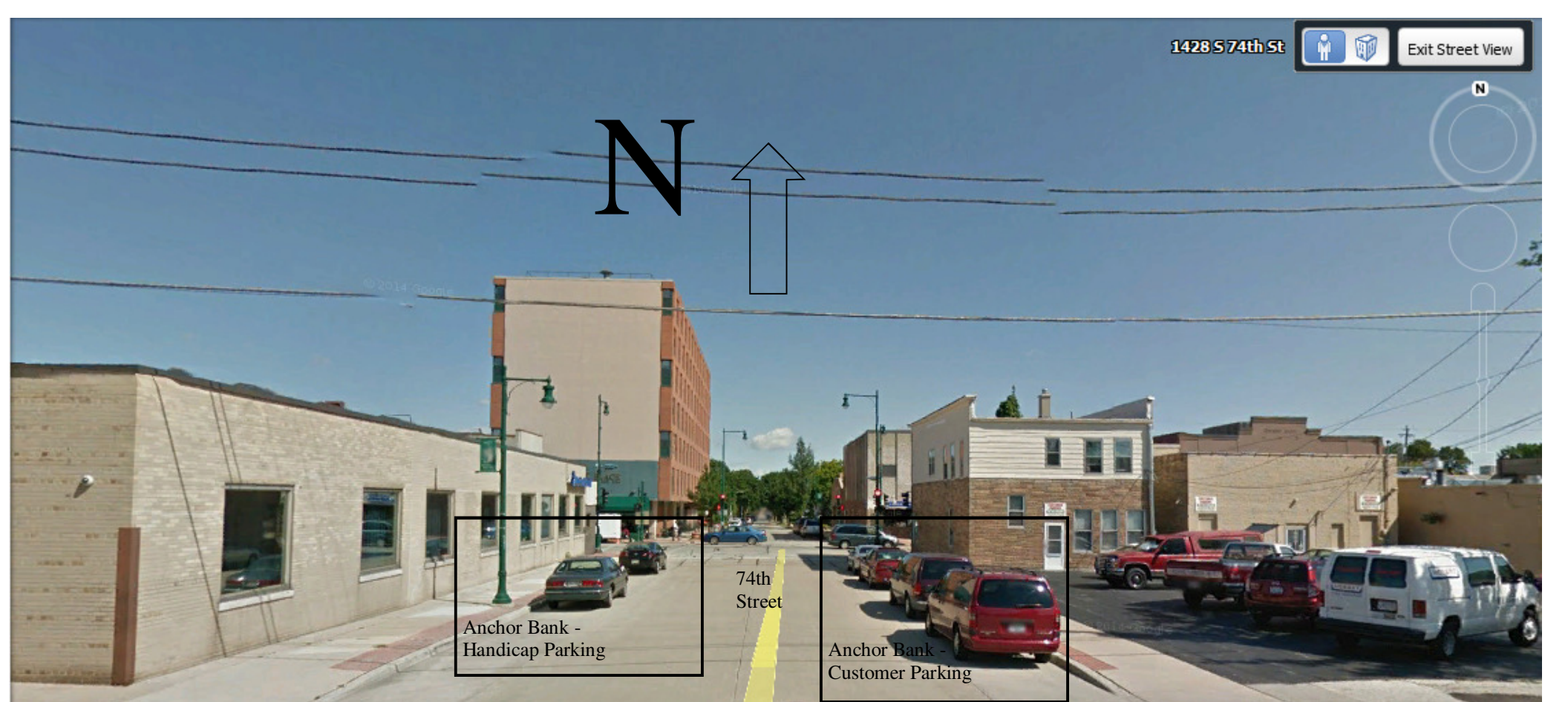
