

**CITY OF WEST ALLIS
RESOLUTION R-2025-5196**

RESOLUTION TO AUTHORIZE THE PURCHASE OF ONE 2026 FORD TRANSIT T-150 CARGO VAN FROM EWALD AUTOMOTIVE GROUP FOR A SUM OF \$53,198.50

WHEREAS, the Public Works Water Division is in need of replacing a 22-year-old van (#100), with a new, more efficient and functional van; and,

WHEREAS, item #69 in the 2025 Capital Improvement Program approved budget includes \$60,000 for the purchase of the van; and,

WHEREAS, Ewald Automotive Group, the State of Wisconsin contract holder, has provided pricing for the 2026 Ford Transit T-150 cargo van for the Public Works Water Division of the City of West Allis; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this contract meets all desired specifications, and that the proposal received is reasonable; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposal of Ewald Automotive Group be accepted.

NOW THEREFORE, be it resolved by the Mayor and Common Council of the City of West Allis that the proposal dated November 11, 2025 by Ewald Automotive Group for furnishing and delivering one 2026 Ford Transit T-150 cargo van for a total sum of \$53,198.50 is accepted.

BE IT FURTHER RESOLVED that this purchase will be charged to Account Number 501-2901-537.70-02.

BE IT FURTHER RESOLVED that the Finance Department is authorized to enter into a contract for the 2026 Ford Transit T-150 cargo van.




