

**CITY OF WEST ALLIS
RESOLUTION R-2026-5221**

**RESOLUTION TO APPROVE A CONTRACT WITH GRAEF FOR PROVIDING
DESIGN AND CONSTRUCTION STAKING FOR W. BURNHAM ST.
RECONSTRUCTION FROM S. 59TH ST. TO S. 61 ST. IN AN AMOUNT NOT TO
EXCEED \$260,000.**

WHEREAS, the City of West Allis is reconstructing W. Burnham St. between S. 59th St. and S. 61st St.; and,

WHEREAS, the street reconstruction includes roadway, sanitary sewer, watermain, storm sewer, street lighting, and streetscaping; and,

WHEREAS, the design and construction staking of the project will require expertise in streetscaping and public input; and,

WHEREAS, the City has successfully worked with Graef on other street reconstruction projects that included streetscaping and public outreach; and,

WHEREAS, the City Engineer recommends the City enter into a professional services contract for the design and construction staking work of W. Burnham St. from S. 59th St. to S. 61st St;

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that it approves a contract with Graef for providing design and construction staking services for W. Burnham St. from S. 59th St. to S. 61st St. in an amount not to exceed \$260,000.

BE IT FURTHER RESOLVED that the city attorney is authorized to make any non-substantive changes to the approved documents to effectuate their intent and to prepare and deliver any other documents necessary to complete the approved transaction.

BE IT FURTHER RESOLVED that the City Engineer is authorized, on behalf of the City, to execute the aforesaid contract documents.

BE IT FURTHER RESOLVED that funding is appropriated from savings from other roadway reconstruction projects.

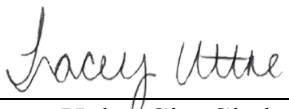

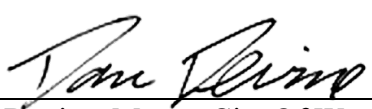
