THE UNDERSIGNED, BEING LANDOWNERS OF ERMENC PARK ESTATES HEREBY PETITION THE CITY TO DO THE FOLLOWING:

- 1) PLEASE RETURN AND POST: The no trucking signs on the south end of East side of 117th street 2700 Bik Cleveland Avenue for northbound trucking traffic.
- 2) ENFORCE: That the no trucking ordinance which is in place on south 117th street, be strictly enforced by the West Allis Police Department trucks entering north and southbound.
- 3) 2010 ASSESSMENT ROAD REPAIR Of SOUTH 117th STREET: Without the above signs in place, and failure to enforce, the violations continue, included in the list of violators, and are the city's own large trucks which have been personally witnessed by the landowners of Ermenc Park Estates. In addition, the W. A. Police patrol cars have blatantly ignored the trucking violators, all which are purposely using this residential street as a "cut-through" at excessive rates of speed! By their failure to ticket violators, this has escalated the breakdown, and abused the permanent concrete street, curb and gutters as it was constructed. This is placing an unnecessary financial burden on the landowners of Ermenc Park Estates on south 117th street. The city was notified years prior of these eroding problems, and were specifically identified in numerous submitted documents, and by our past speaking and attendance at common council meetings. The city's flagrant ignoring of our pleadings has gone on as excessive gross negligence to now place us in considerations of a costly repair to south 117th street. We are under the understanding that an alleged assessment is in the works for minor repair ordered for S. 117th Street at approx. \$28.06 per front foot for asphalt. The total figure for the assessment is approximately \$50,876.00 for 13 individual properties that are located on the west side of south 117th street. We also have information that Nathan Hale High School will be assessed approx. \$60,000.00 to \$70,000.00 dollars for their assessed portion. This includes the street area from Lincoln to Cleveland A

We object to the pending assessment for minor road repair, as we lead to the city official's unlawful disregar damages created, our personal safety and well being, the value of of our tax bills, and overall lasting effects of repairs.

We feel that without the above as itemized in numbers 1-3, that these the restrictive covenant set forth when this sub-division was created, and nas impacted and compromised our quality of life. The safety issues and endless problems that have ensued without these items in place have set a bad precedent which will permit the degradation and devaluation of our existing streets and our subdivision.
