

**CITY OF WEST ALLIS
RESOLUTION R-2023-0610**

**RESOLUTION AUTHORIZING THE HEALTH DEPARTMENT TO ACCEPT AND
EXPEND FUNDING FROM STATE OF WISCONSIN/WISCONSIN DEPARTMENT OF
HEALTH SERVICES**

WHEREAS, the Wisconsin Department of Health Services will provide Wisconsin Environmental Public Health Tracking Program funding to the West Allis Health Department to address mental health outcomes of rodent infestations and the community wide rodent contraceptive program in West Allis Neighborhoods.

WHEREAS, the City of West Allis has been awarded \$10,000 by the Wisconsin Environmental Public Health Tracking program for the period August 1, 2023 to July 31, 2024.

WHEREAS, funds will be used to implement the rodent contraceptive program and assess mental health impact of rodent infestations.

WHEREAS, the West Allis Health Department serves as the agency responsible for administering these funds; and,

WHEREAS, the 2023 budget did not include an appropriation for the Environmental Public Health Tracking Program grant.

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis:

1. Authorizes the West Allis Health Department to accept Environmental Public Health Tracking Program funds; and
2. Appropriates and amends the 2023 City Budget to allow for the expenditure Environmental Public Health Tracking Program funds as allowed in the grant program; and
3. That the Health Commissioner is hereby authorized and directed to take any and all other actions deemed necessary to effectuate the intent of this Resolution.
