Final Action:

Resolution Relative to the Transfer of \$125,000 from the Contingency Fund to the Police Department's 2003 Capital Equipment Budget (221-599.00) for Upgrade to the Police Department's Mobile Data Computers.

WHEREAS, the Police Department is in need of upgrading its mobile data computers that are equipped in each squad car; and,

WHEREAS, the cost of each mobile data computer for the Police Department's thirty (30) squad cars is \$3,000-\$3,400; and,

WHEREAS, at the end of 2002, the Police Department returned approximately \$400,000 to the General Fund; and,

WHEREAS, the Police & Fire Commission has approved the upgrade of the mobile data computers; and,

WHEREAS, funding for the upgrade may be necessary yet in 2003 before 2004 budgeted funds become available.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that \$125,000 is hereby approved for transfer from the City's Contingency Fund to the Police Department's Capital Improvement Program Account (221-599.00).

RE: Use of contingency funds for the upgrade of mobile data computers

Dear Mayor Bell and Members of the Council:

At the December meeting the Police and Fire Commission approved the upgrade of the mobile data computers for our squad cars. This expenditure was approved after the Commission received documentation from the Finance Division showing the Police Department was more than \$400,000 under budget. For additional information pertaining to the budget, I have enclosed the 2002 expenditure report.

Each marked squad car is equipped with a mobile data computer. These computers are essential for the efficient operation of the Patrol Division. Because of regular maintenance and new technology these computers have to be upgraded every few years. The transmitter and radio modems currently in use are approximately 10 years old. The transmitter is located on a private tower in Brookfield and will no longer be available to us. This transmitter is based on old technology and has a very slow data transfer rate. The trend in mobile data computing is toward access to important information that officers on patrol immediately need such as:

- Mugshots
- Information on crime statistics and criminal activity
- Computer generated parking and traffic citations
- In-car reporting with a wireless network connection
- GPS, which would provide the exact location of squads

These types of capabilities require a faster data transfer rate. For these technologies to become a reality, it will be necessary to upgrade to the next generation of MDC transmitting technology. In addition to the transmitters being replaced, it would be necessary to replace the radio modems in each squad. Since thirty squads are equipped with MDC's, this would be the most costly part of the upgrade. The cost per squad is estimated at \$3,000 to \$3,400, however these are preliminary figures. Inspector Dietrich and Computer Network Specialist Jim Jandovitz are on a committee to determine the most cost effective way to upgrade the MDC's. We hope to find a less expensive alternative and still be able to provide the necessary information to our patrol officers.

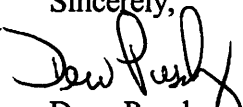

It should be noted that this change will affect at least 15 other area police departments. The total cost of this upgrade will be approximately \$125,000. The Police and Fire Commission initially approved carrying funds over from the 2002 budget. However, after discussing this matter with Paul Ziehler we felt it was more appropriate that contingency funds be used for this expenditure.

I respectfully request that you approve the transfer of \$125,000 from contingency funds to the Police Department capital improvement program account (100-221-5-599.00) to upgrade the mobile data computers.
