I am writing to formally request a waiver of towing fees related to the wrongful tow of my vehicle on 11/11/2025

Prior to parking, I obtained permission from the West Allis Public Library and confirmed approval with the West Allis Police Department to park on the property in question. Despite following the proper protocol, my vehicle was towed after a complaint was made, possibly by a neighbor. This action was taken even though I had explicit authorization to park.

Additionally, I have attached supporting documentation, including:

A letter from the library confirming that my vehicle was permitted to be parked in their lot.

The towing notice, including fees and the date of disposal. I currently have no money to retrieve vehicle!

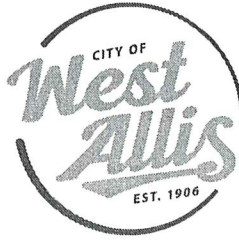

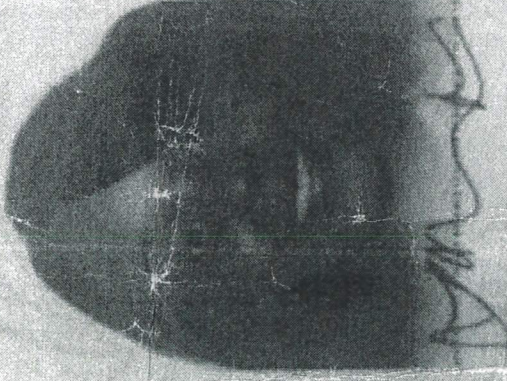
