INCIDENT REPORTS:

TAVERN RELATED INCIDENTS NOT REQUIRING INCIDENT REPORT:

CALL #18-031319// 3 August 2018 at 2221hrs// Dopps Bar- 1753 S. 68 St **NO TAVERN VIOLATION**

Trouble Call: Officer Wagner reports**TROUBLE CALL ** On 08/03/18 at 2221hrs, I responded to Dopps Bar at 1753 S 68 St for a report of a fight. Upon arrival the bar was calm and nearly empty. Dino D Curi, M/W, stated he had called after Ross J Rome (M/W) struck him on the chest during an argument. Ross was highly intoxicated at the time. I spoke with the bartender, Walter P Pezall, M/W, he advised the two had been arguing, then Dino had sat down directly next to Ross. Ross reached his arm out and struck Dino once in the chest. Dino advised he had no injuries from the incident. Ross was given a curtesy ride home as he was highly intoxicated and did not need to be drinking any further.
