Dear Mayor of West Allis:

In accordance with Section 7.30(4) of the Wisconsin Statutes, which provides that the two dominant political parties shall provide a list of nominees for election inspectors by November 30 of each odd numbered year, the Republican Party of Milwaukee County (RPMC) is pleased to submit the enclosed list of persons who are being nominated as election inspectors by the RPMC. I hereby certify that either our Chairman of the Elections, Committeemen, and Pollworkers Committee of the RPMC, Republican Party of Wisconsin staffperson David Bredemus, or one of our Branch Chairs has contacted each nominee who appears on the list and each such nominee has agreed to serve as an election inspector. Please appoint the individuals on the enclosed list as election inspectors for a two year term, beginning January 1, 2016 through December 31, 2017.

In addition, Section 6.875(4)(a) of the Wisconsin Statutes provides that each team of two Special Voting Deputies that are to be sent to nursing homes (etc.) for the collection of absentee ballots should be one from each of the two dominant political parties if possible. Therefore, pursuant to Section 6.875(4)(b) of the Wisconsin Statutes, we hereby appoint the individuals on the separate enclosed list as Special Voting Deputies.
